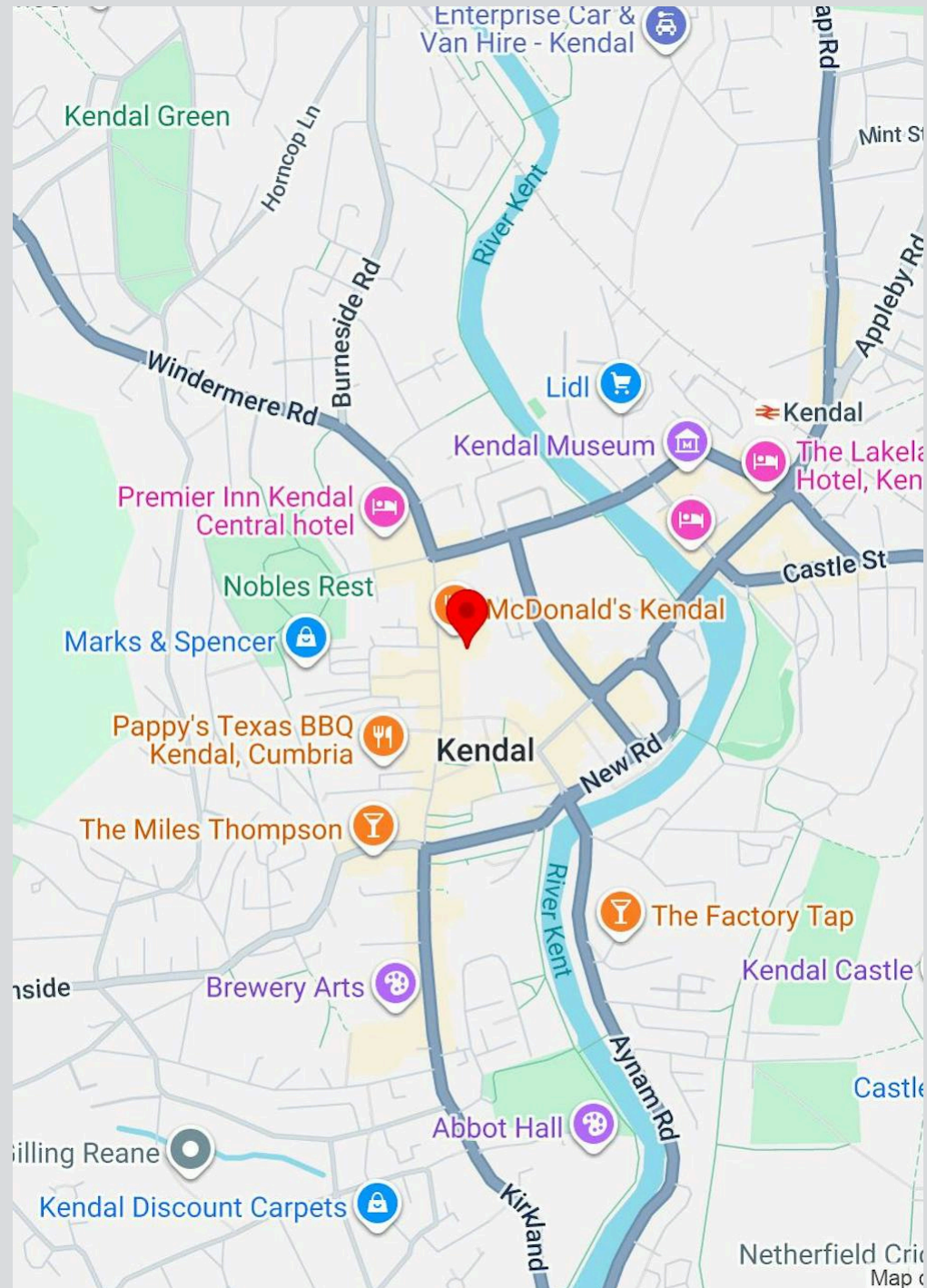

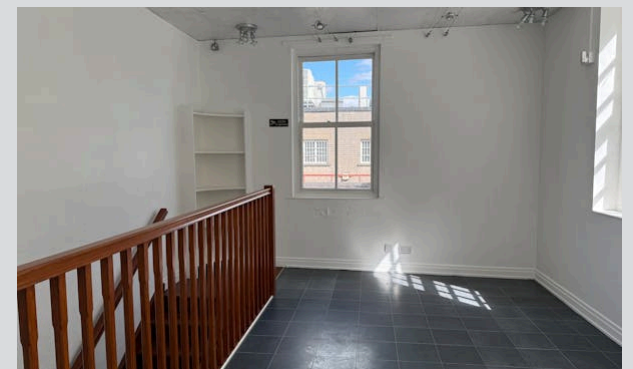


LOCATION
