LOCATION

The property is situated within the South Ruislip Industrial District in a prominent position fronting directly on to Stonefield Way which in turn links to Victoria Road, giving access to the A40 via the A4180, West End Road. The A40 links to Central London, the M40, M25 and the National motorway network. South Ruislip Underground Station (Central Line) is with 1 mile of the property.

DESCRIPTION

Newly constructed in 2021, this modern warehouse / distribution unit benefits from a steel portal frame construction with profile metal-clad elevations beneath a pitched roof. The ground floor provides a reception/showroom area alongside clear, open-plan warehouse accommodation, with access via five full-height electric shutter doors which are serviced by an excellent, securely gated yard, benefiting from two independent points of access. Additional mezzanine storage is provided at first-floor level. The building further benefits from three-phase power, solar panels, and an impressive maximum internal height of approximately 8.41 metres. The property is to be sold with full vacant possession.




