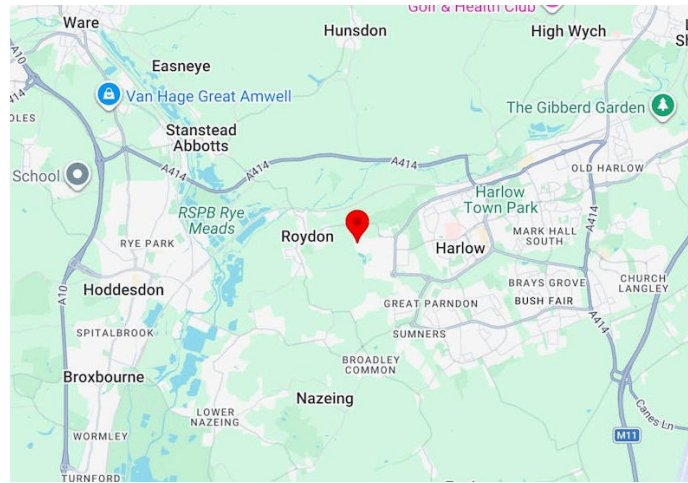

## Description

The Property comprises a modern mid-terrace purpose built two storey business unit.

The ground floor accommodation comprises two partitioned offices to the front of the property. To the rear of which is a well presented kitchen and accessible WC.

## Location

The Property is situated on Harlow Business Park, which was developed in phases from approximately 1990.
