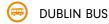
### **LOCATION**

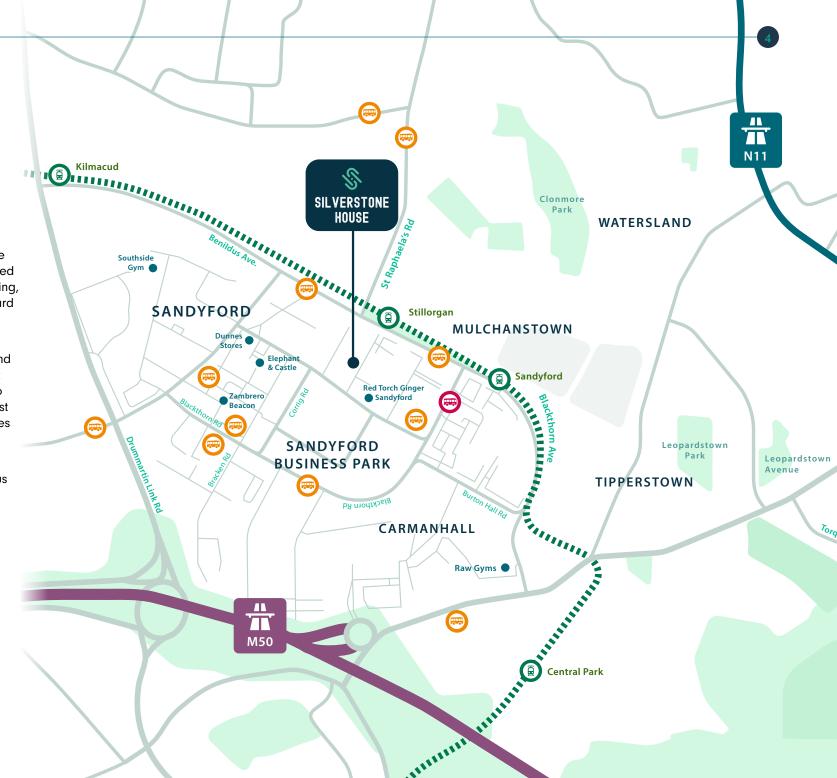
