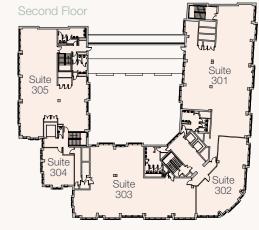
Lower Ground Floor
