Description

ARC Aylesford comprises a modern development completed in 2021 that provides a range of high-quality logistics units plus a Costa Coffee and McDonald Drive Thru. On offer are units B&C which are configured as a single unit 39,367 sq ft plus Unit D, a detached unit of 18,606 sq ft all within a site of approximately 2.5 acres including a secured yard of 1.1 acres. The units offer modern, well specified accommodation built with 10m eaves with 3,800 sq ft of additional offices space installed by our client in Unit B & C, 30 - 35m yards and a power supply of 150 KVA in D with both B and C having 200 KVA each. The units have been enhanced by the current occupiers with high quality welfare, office and breakout spaces, meeting rooms, kitchens, lockers and WC facilities that are available to new tenants. The units are also avail as B & C, or D or all three subject to negotiation.

Arc Logistics Park combines grade-A warehouse units with an adjacent Ecology Park to create an enhanced logistics development with ‘green’ breakout space. The Ecology Park includes; wildflower grassland maximising biodiversity, that included the installation of a butterfly bank to promote priority species and habitat piles to provide habitat for invertebrate species.

Sustainable features include photovoltaics on every building, LED lighting and the installation of EV charging points, all of which contribute to a reduction in energy use and CO2. Natural light flooding through large windows combined with generous roof-lights in the warehouse reduces the amount of energy needed for lighting - and makes the buildings a more pleasant space to work in.



Location

ARC is strategically located off the A228 provided fast access to both the M20, M2 and M25 motorways, essential for distribution and logistics companies serving London and the wider South East. The Channel Tunnel, and Kent Ports are all within an hour's drive, providing access to Europe and beyond. With 35 million people living within 4.5 hours’

ARC boasts strong public transport links, Snodland railway station 1.1 miles away, and local bus routes close by, plus on site food facilities provided by McDonald’s and Costa.

Larkfield and Snodland as a strategic location has attracted both National and local occupiers that include Swegon, Amazon, Brakes, BT, DFS, Dixons KnowHow, DPD, Euro Car, Parts, Kier, Polypipe, SIG, Tesco, Waitrose, Marley and XPO.

Terms

Units B & C have an existing 15 year FRI lease which expires 07/07/2036 at passing rent of £368,719.50 pax (£10.00 per sq ft on the base unit / £9.37 per sq ft on the unit with tenants extended offices.)

There is a tenant break on the 7<sup>th</sup> July 2031, and an upward only rent review on the 7<sup>th</sup> July 2026 and 2031.

The current tenants have extended the offices, which will be excluded from the lettable area offering an occupier an occupational savings for the remaining term of the lease.

Service Charge for the 25/26 year is £0.70p psf and is also subject to a cap.

Terms

Unit D is held on an existing 15 year FRI with a condition sub-lease which expires 01/09/2031 at a rate of £206,164.00 pax which equates to £14.41 on the original base unit GEA of 14,300 sq ft. The lease is granted Outside the Act,

There is a rent review on the 2<sup>nd</sup> September 2026 and on the 2<sup>nd</sup> September 2031. The next review to increase to a rate of £14.41 per sq ft and the 2031 review £14.41 on the original base unit. This is considered substantially below current market rents offering an occupier substantial savings over the remaining term of the lease and rent certainty.
