## Description

Unit 5 located on the first floor provides a self-contained office suite accessed via a communal entrance with both stairs and a passenger lift.

Internally the suite is arranged as a typical office suite with reception area, large open plan office, three additional office/meeting rooms, board room, and kitchen with breakout area.

The offices have been finished to a good specification and include LED lighting, suspended ceilings, heating and comfort cooling, raised access flooring and double glazing.

Externally the property provides excellent on site parking provision for 8 cars. Additional parking may be available.



## Location

Brindley Court is situated just off Gresley Road which adjoins both Wainwright Road and Berkeley Way (B4639).

The estate has excellent access to Junction 6 of the M5 motorway which lies 1.2 miles to the east and Blackpole Trading Estate and Blackpole and Elgar Retail Parks 1.4 miles to the west.

Worcester city centre is approximately 3.3 miles to the south west along with both Shrub Hill and Foregate Street train stations.

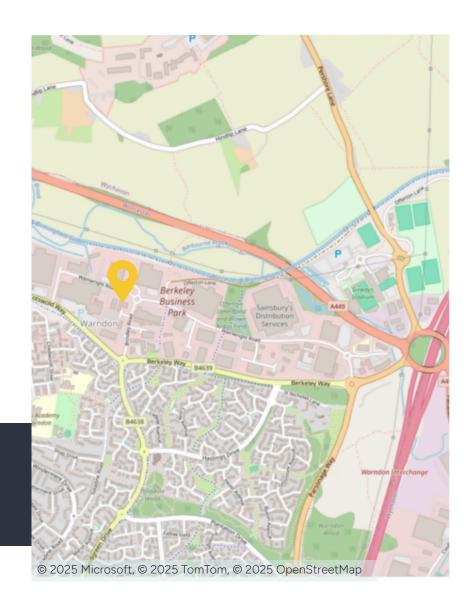
