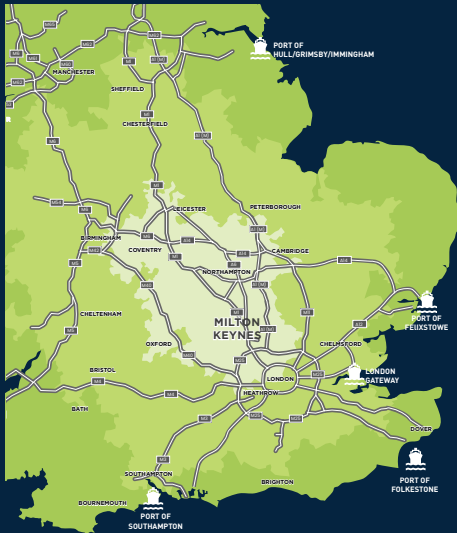

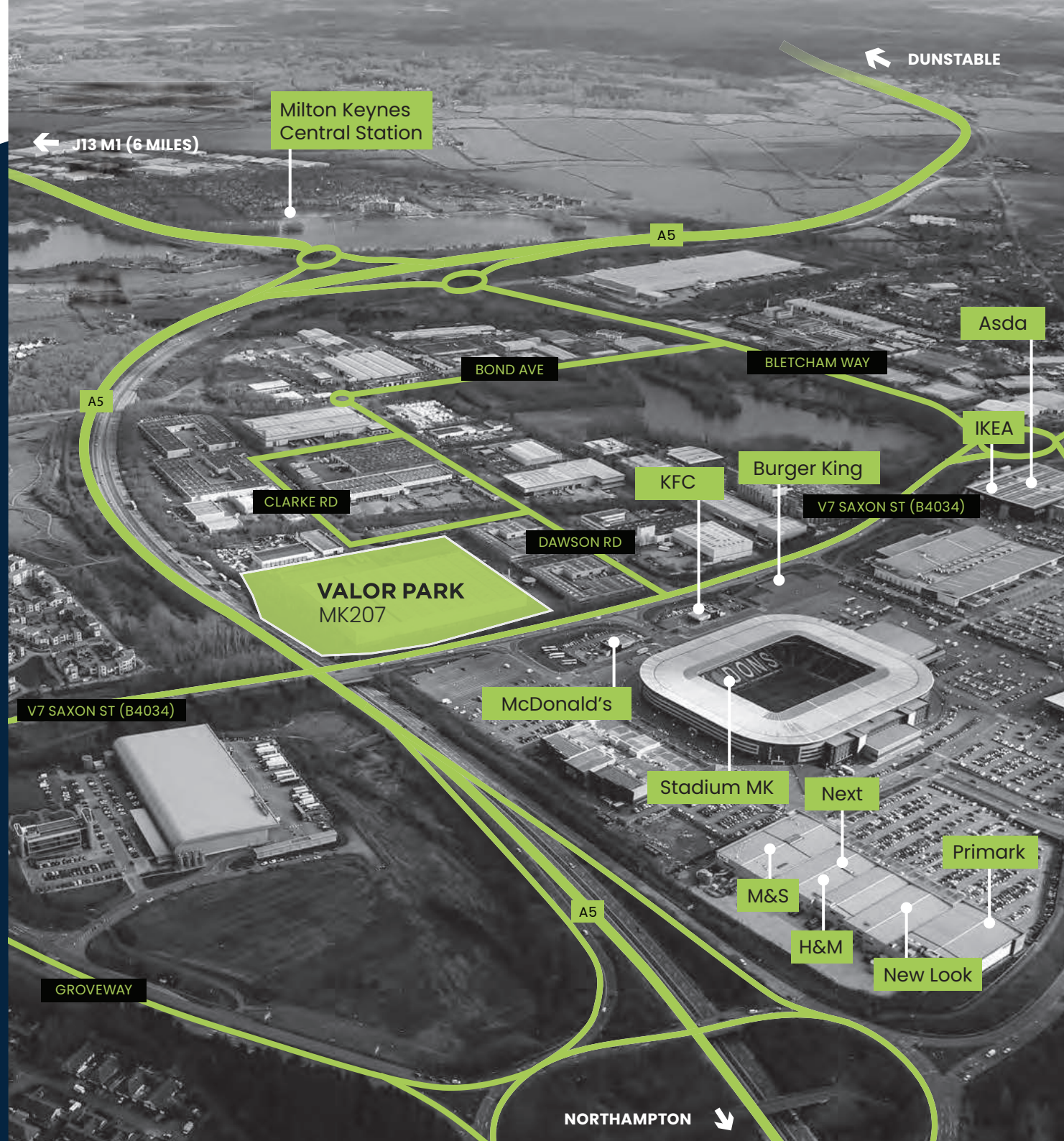

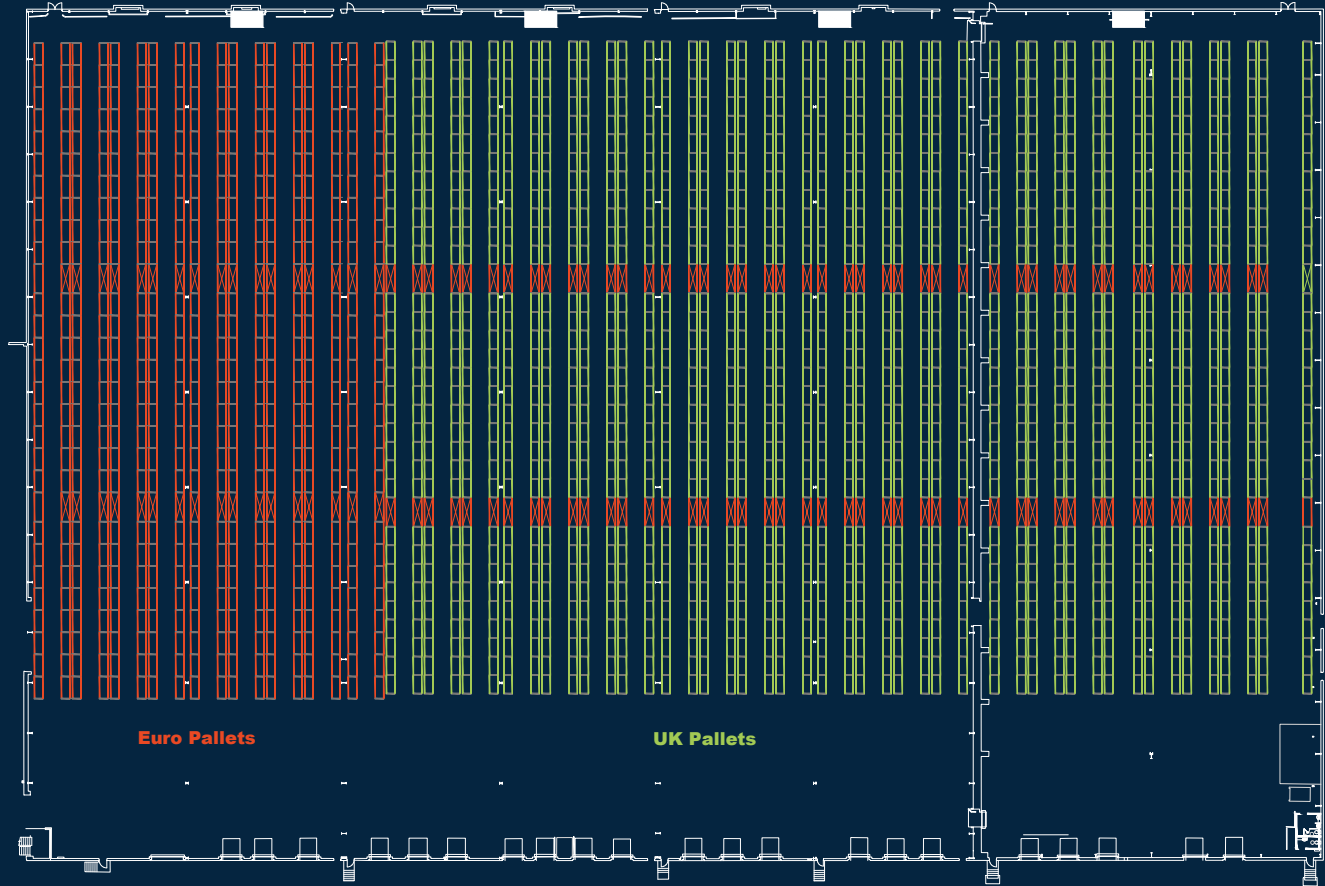

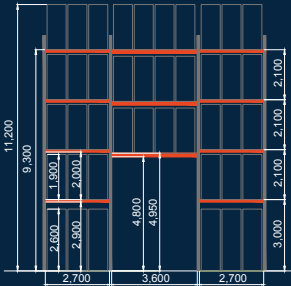

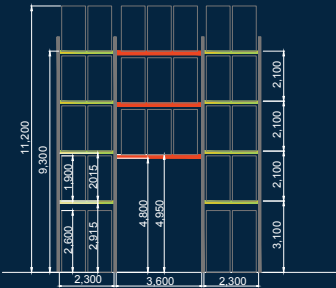
RACKING PLAN
