## LOCATION

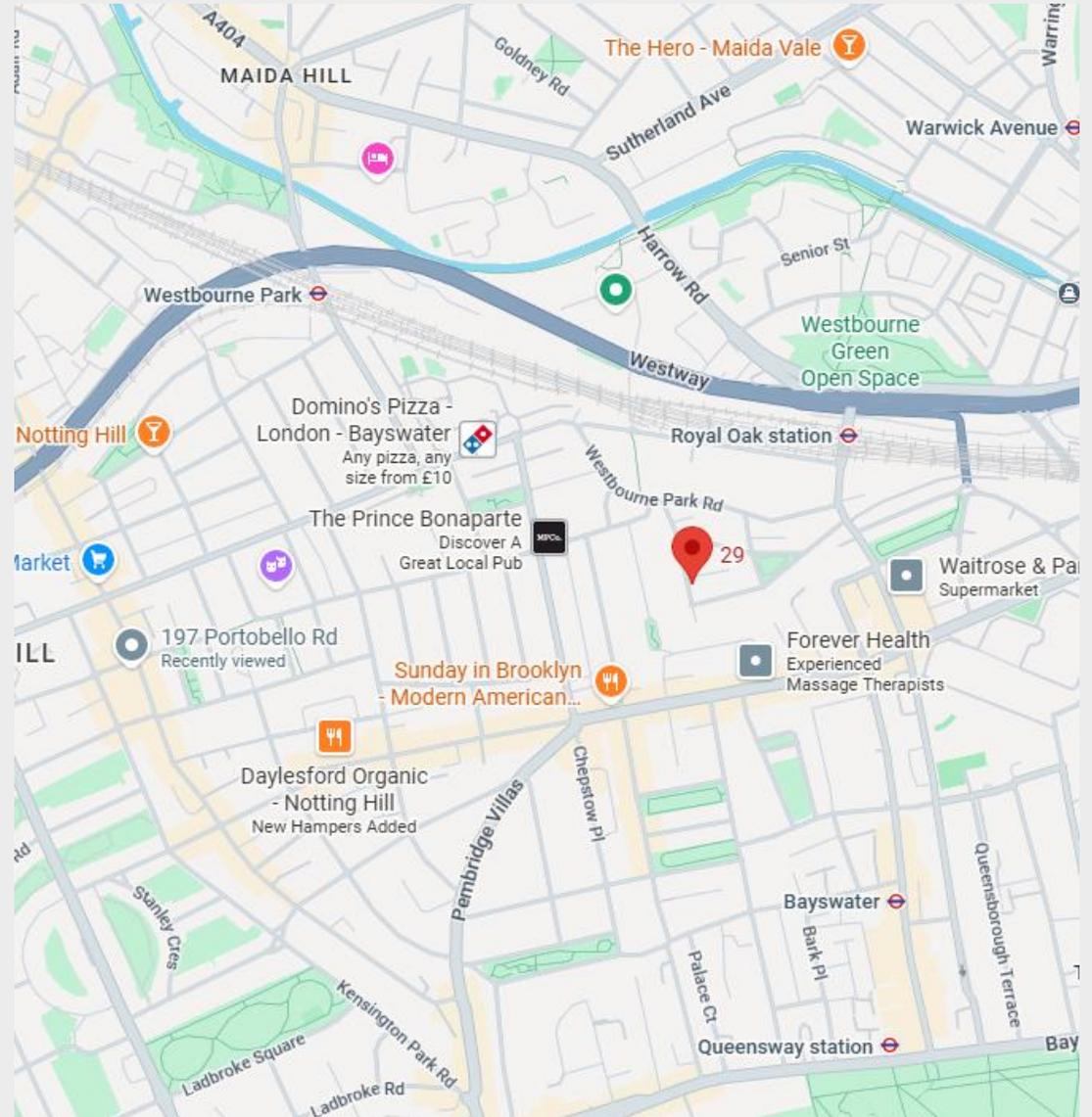
29 Alexander Street is a prestigious mainly residential road located within the W2 postcode in Westbourne Park.

The street is characterised by attractive period terraces and converted townhouses.

The property benefits from proximity to the independent cafés, neighbourhood pubs and convenience retail of Westbourne Park and nearby Ledbury Road, together with the wider retail and leisure offering of Paddington, Bayswater and Queensway.

Transport connections are excellent. Westbourne Park Station is within easy walking distance, providing Circle and Hammersmith & City line services. Royal Oak Station is also nearby, while Paddington Station offers National Rail services, the Elizabeth Line, Heathrow Express and multiple Underground lines, giving rapid access to the West End, the City, Canary Wharf and Heathrow Airport. Road access to the A40 (Westway) provides convenient vehicular links to central London and the M40 corridor.

Hyde Park is situated to the south, offering extensive open space and recreational facilities.



## DESCRIPTION

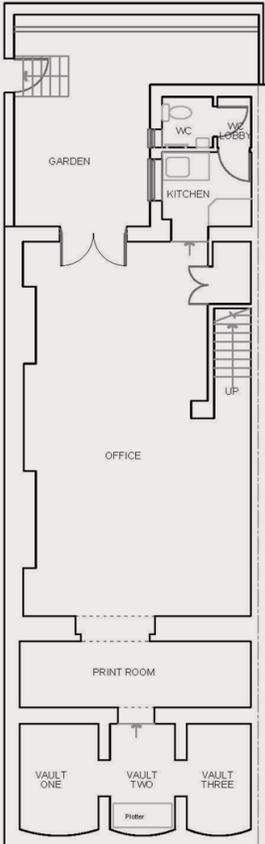

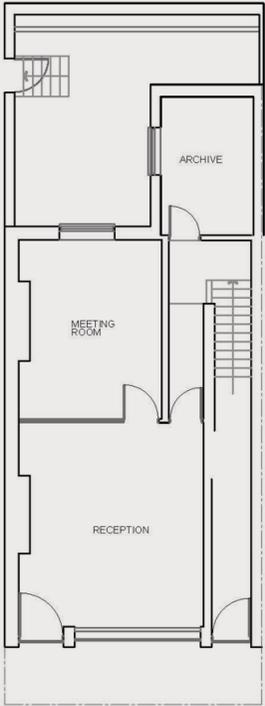
The unit is approximately 1,115 sq. ft. (excluding Vaults 1,247 sq.ft. including the vaults).
