62 Home Street occupies a position within a well-established mixed-use area to the south-west of Edinburgh city centre. Home Street acts as an important local thoroughfare linking the Bruntsfield, Tollcross and Fountainbridge suburbs and benefits from high levels of vehicular and pedestrian traffic.

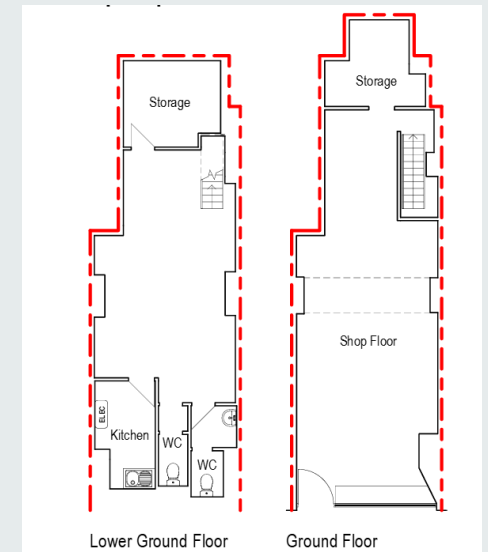

DESCRIPTION:

The subjects comprise a mid-terrace, ground floor and basement Class 1A premises situated within a traditional stone-built tenement property.

Internally, the property is configured with a large open plan sales area on the ground floor that leads to a rear staircase that descends to a full head height, basement space with WC facilities and tea prep/staff area and additional storage.

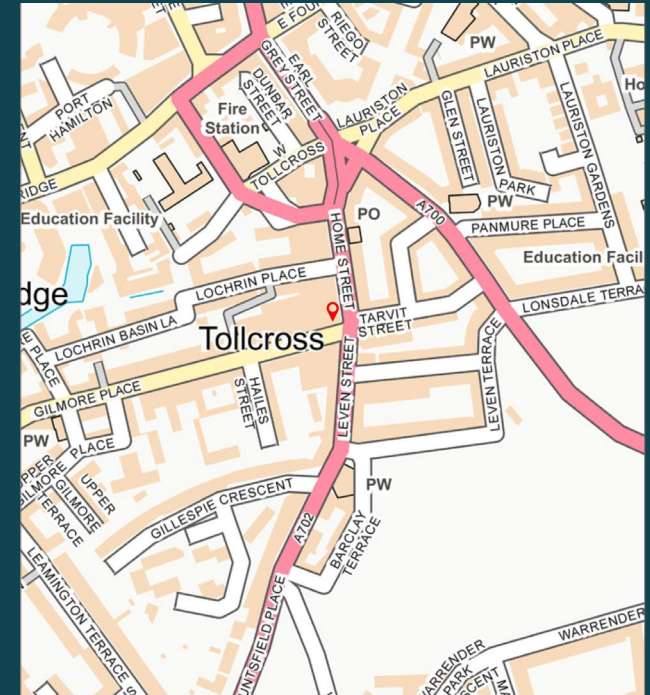
