

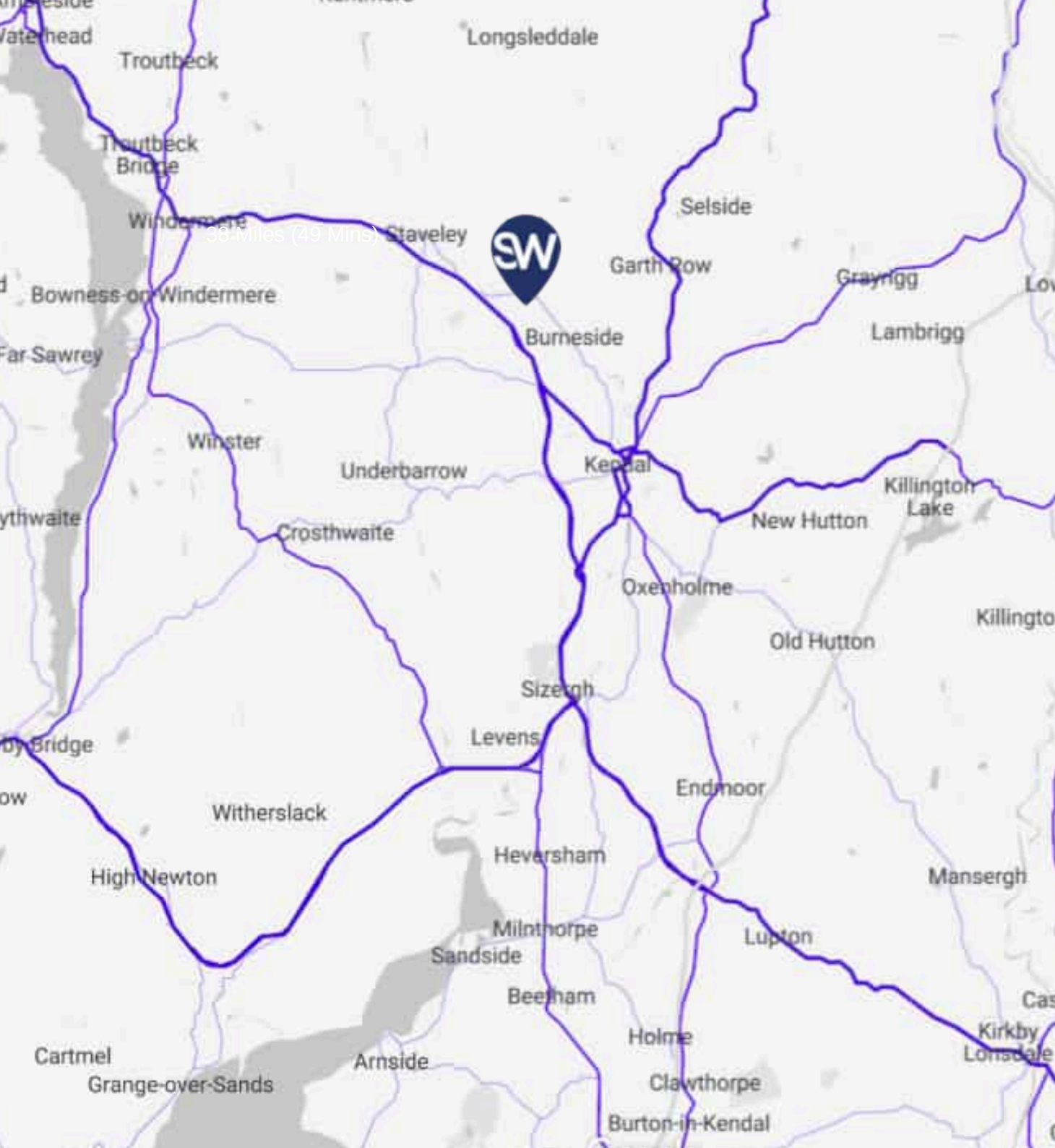

Location

The property occupies a prominent roadside position at Plantation Bridge, around 4 miles north of Kendal town centre, fronting the busy A591 the main route between Kendal, Windermere and the wider Lake District.

The site benefits from strong visibility to passing traffic and excellent connectivity, with Junction 36 of the M6 located approximately 6.5 miles to the south-east. Kendal railway station is 2.8 miles away, with further regional connections available at Oxenholme Lake District station, around 5 miles to the south.

The surrounding area comprises an established cluster of roadside retail and trade operators, including car dealerships and vehicle-related businesses, with Kendal and Windermere providing additional footfall from local residents, commuters, and significant year-round tourism. This stretch of the A591 benefits from consistent traffic volumes, supporting retail and showroom-led uses.

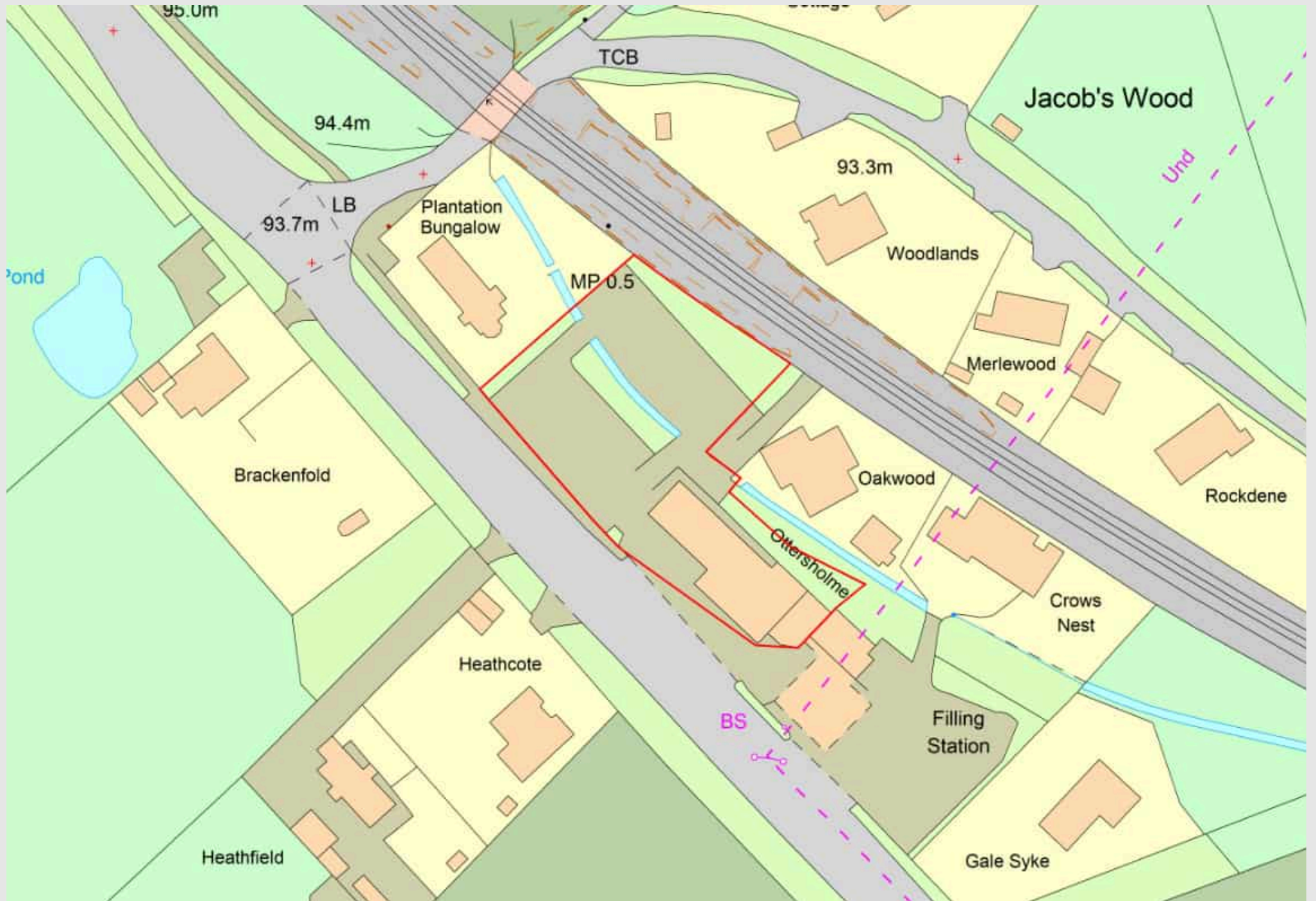
