

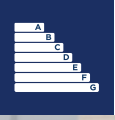

Location

Charterpoint is located just off Junction 13 of the A42, thereby having direct and quick access to the A511 / A42 / M42. Charterpoint Office Park is close to Ashby-de-la-Zouch town centre which lies circa 1 mile to the west. Charterpoint is very near to a large Tesco superstore and a Marks & Spencer food hall.



Description

The building comprises a two storey mid terrace modern office building. It has traditional brick elevations under a pitched tiled roof.

Internally, the ground floor comprises an open plan layout with WC and kitchen facilities.

The first floor is accessed via a stair well and is also open plan but with some demountable partitioning erected for meeting rooms/private office space. It also has its own WC facilities.

The specification includes the following:

- Carpeted floors.
- Raised access floors.
- Suspended ceilings with inset lighting.
- Air conditioning/comfort cooling system via ceiling mounted cassette units.
- Open plan layout.
- Double glazed aluminium framed windows.

Externally there are 6 on site car parking spaces.

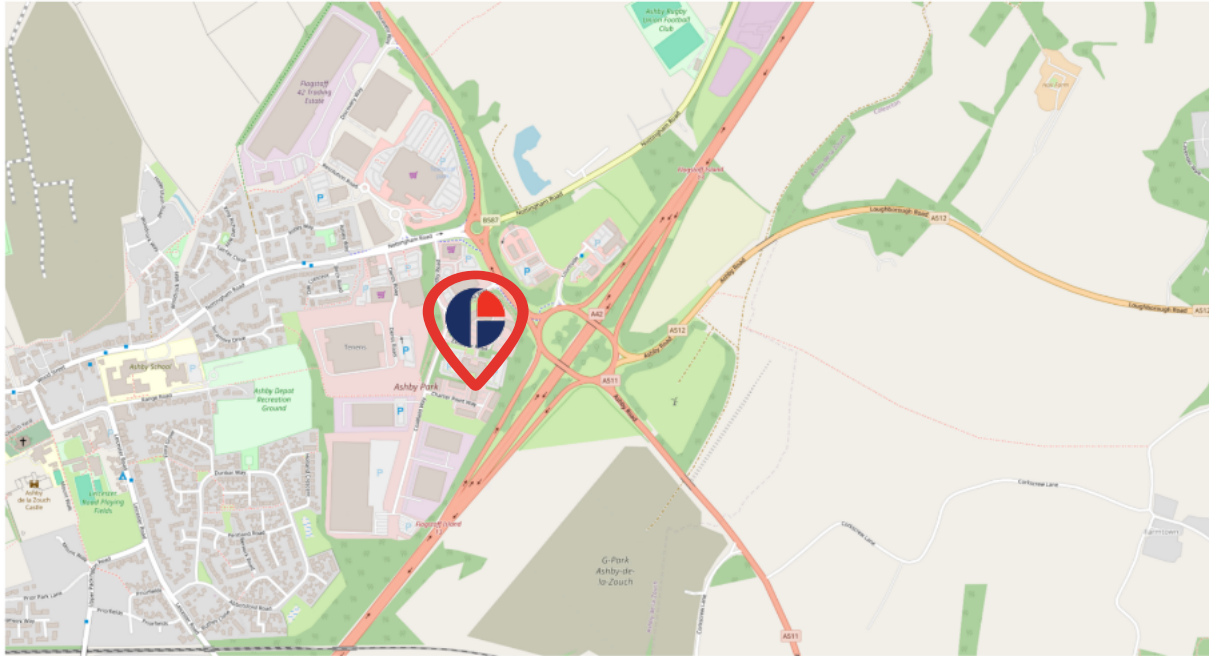

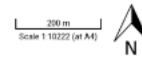
