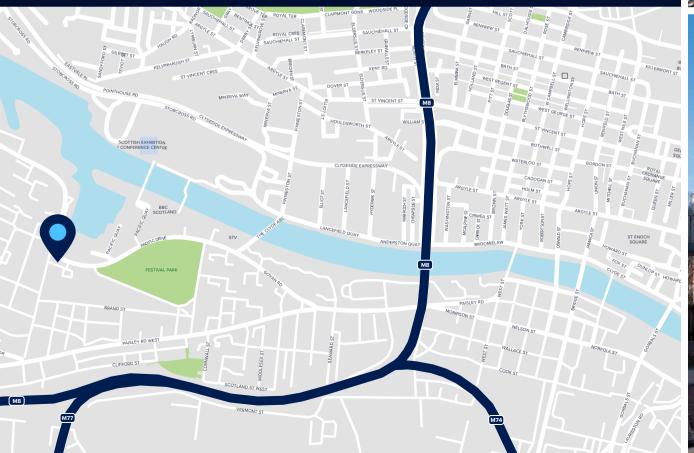

LOCATION

Watermark Business Park is located on the south side of the River Clyde approximately 3 miles from Glasgow City Centre. The Park is located off Govan Road immediately adjacent to Pacific Quay, which has the headquarters for BBC Scotland and Scottish Television as well as office buildings, hotels and gym facilities. The SECC and Hydro are immediately on the other side of the river as well as pedestrial bridges, further hotels and Finniestons bars and restaurants.

This modern 2-storey detached pavilion was constructed in 2009 and is over two floors, capable of single or separate let.

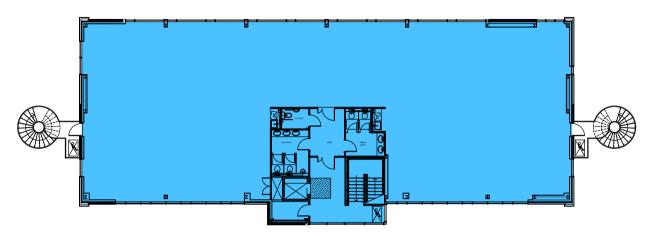

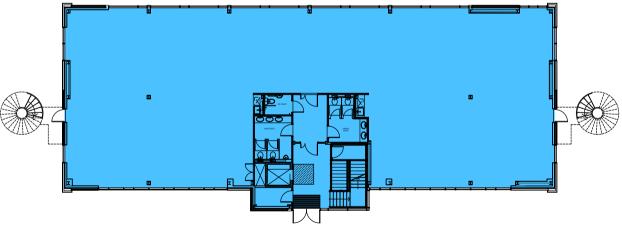

Indicative Floor Plans: Not to scale.



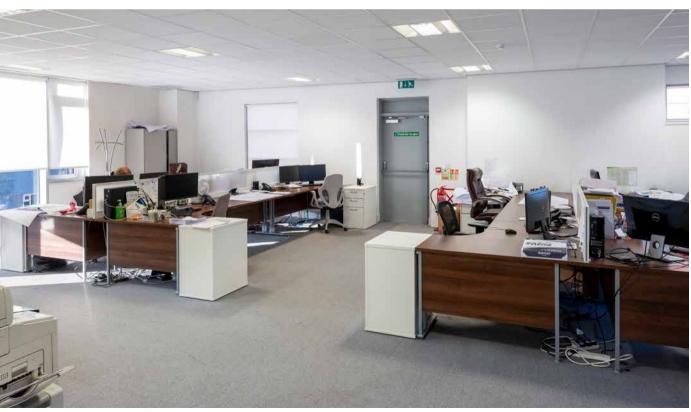












RATING ASSESSMENT

The property will require to be re-assessed for rates as a whole.

The first floor Rateable Value is £52,000.
