LOCATION

The property is situated within the Salisbury Road Retail Centre, a small purpose-built scheme positioned on the edge of the town centre, fronting Salisbury Road (the A354), one of the principal arterial routes into Blandford Forum.

Salisbury Road provides easy access to the wider Dorset road network, with the A350 Blandford bypass connecting to Poole, Bournemouth and Shaftesbury.

The property is located adjacent to a Pets Corner pet store and has until recently been occupied by Co-operative Food as a convenience store. The location provides strong visibility and convenient access for both vehicular and pedestrian traffic.

DESCRIPTION

The property forms part of small development of two retail units with shared parking. Internally the property is arranged with a main open plan sales area, rear stock room with ancillary staff accommodation and WC facilities.

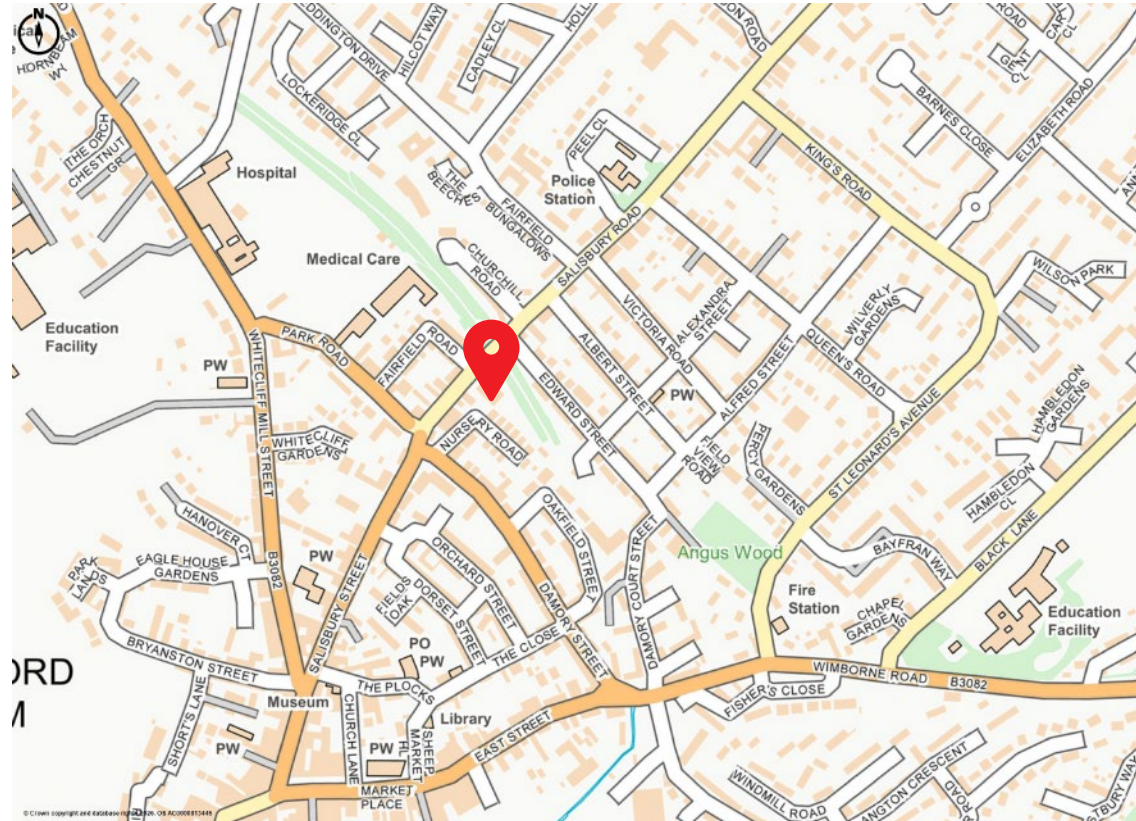
The unit benefits from an air conditioning system, suspended ceiling with inset lighting, automatic sliding doors and rear loading access. There are 13 shared car parking spaces located directly in front and to the side of the Pets Corner unit.
