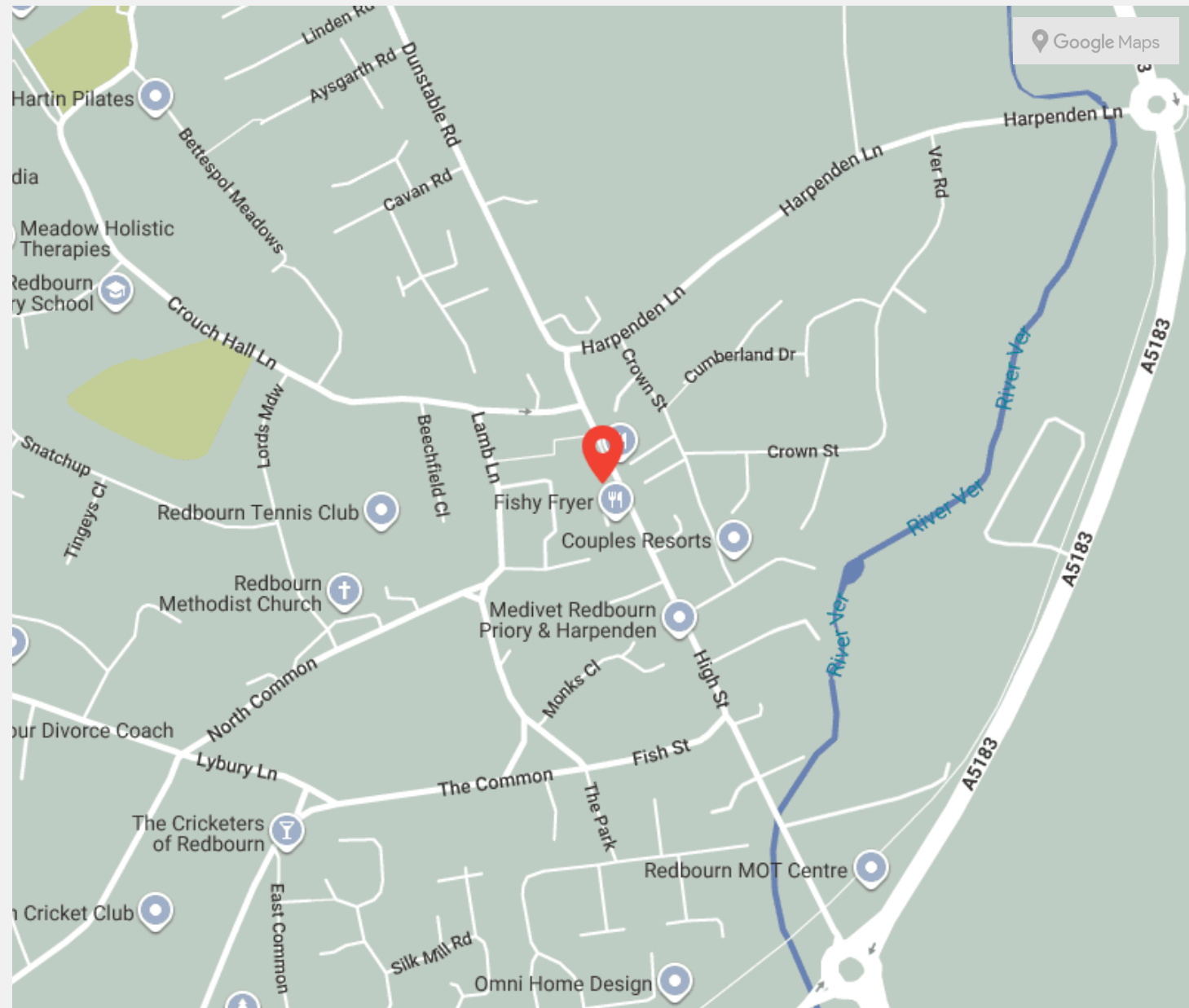
M1 Junction 9 - 2 miles
