**Location:**

- Located on New Briggate next to the top entrance to The Grand Arcade, which is adjacent to the Grand Theatre and Opera North.
- New Briggate is the extension of Briggate, the principal pedestrianised shopping street in Leeds, extending north beyond The Headrow.
- The unit is located adjacent to popular bar Brotherhood of Pursuits & Pastimes.
- The Grand Arcade is a stunning Grade II listed building, with tenants including Zaap Thai, Stuzzi, Roxy, Ohana Bar & Restaurant, NQ64, Lords Barbers/ Domino Club, Tailors, Sonder & Alfonso's Deli.
- The surrounding area currently supports approximately 9,000 existing residential and student beds, with further developments in the pipeline, providing a strong customer base.

**Accommodation:**

- The available space is c. 1854 ft<sup>2</sup> over 3 floors:
  - ◇ Ground Floor 815 ft<sup>2</sup>
  - ◇ First Floor 641 ft<sup>2</sup>
  - ◇ Second Floor 398 ft<sup>2</sup>
- The ground floor benefits from a fully glazed shop front, providing excellent visibility.
- Currently fitted as a bar and beer cellar
- Potential for repurposing into alternative uses including a restaurant or café or retail, hair & beauty, subject to necessary approvals.
- There is also an opportunity for external seating, subject to pavement licence from Leeds City Council (which is currently approved).



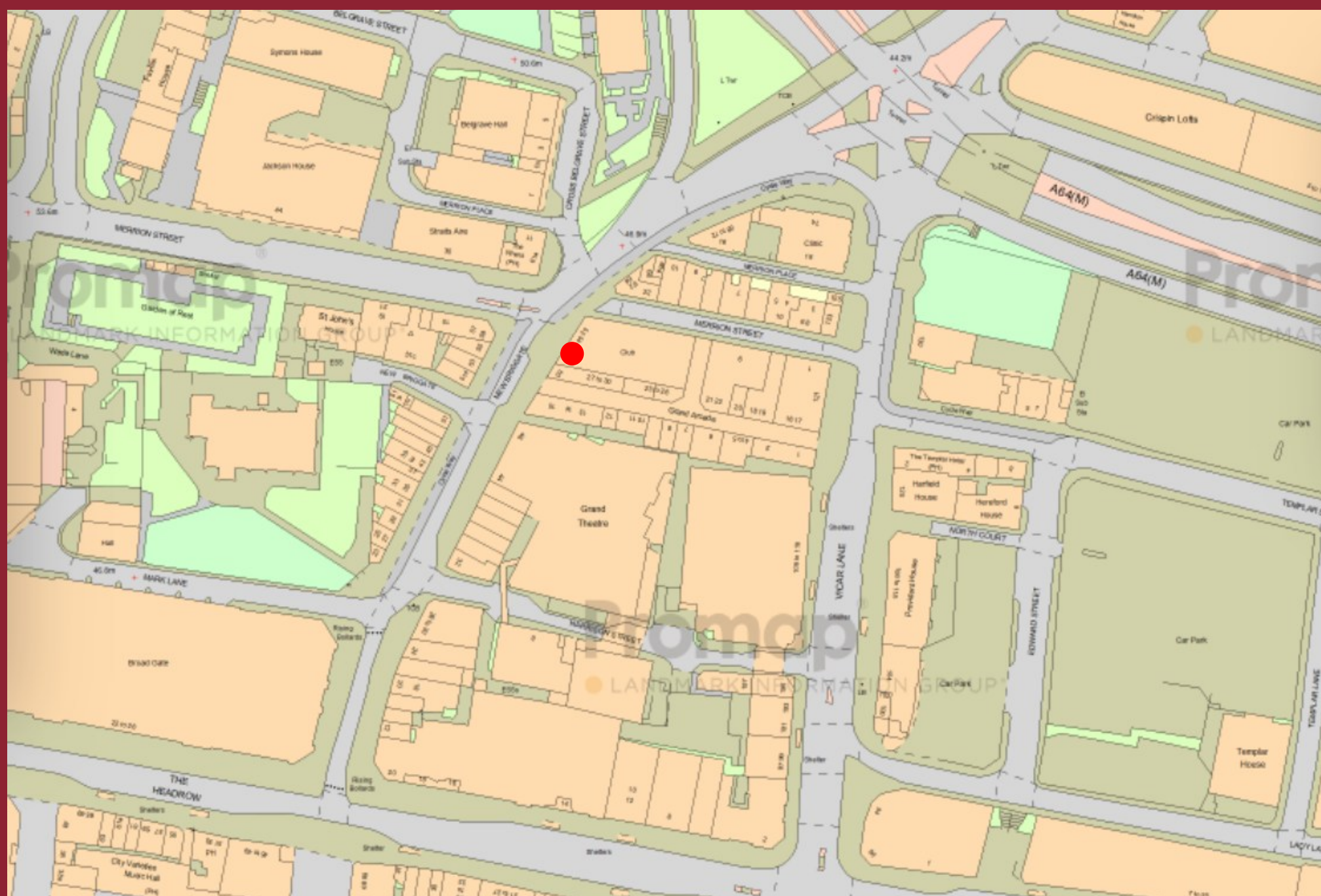
## Opportunity & Location:

The subject property is situated next to the entrance to the Grand Arcade, a well-known and respected Grade II listed building in the Northern Quarter. There is a well-established F&B circuit nearby, with popular bars and restaurants such as Mojoes, NQ64, ZAAP, Stuzzi, Roxy Ball Rooms, and the Arcade's quality independent operators such as Dominos, Alfonso's, Ohana Bar & Restaurant. In addition there are other uses within the arcade including Tailors and Sonder, a new lifestyle store.

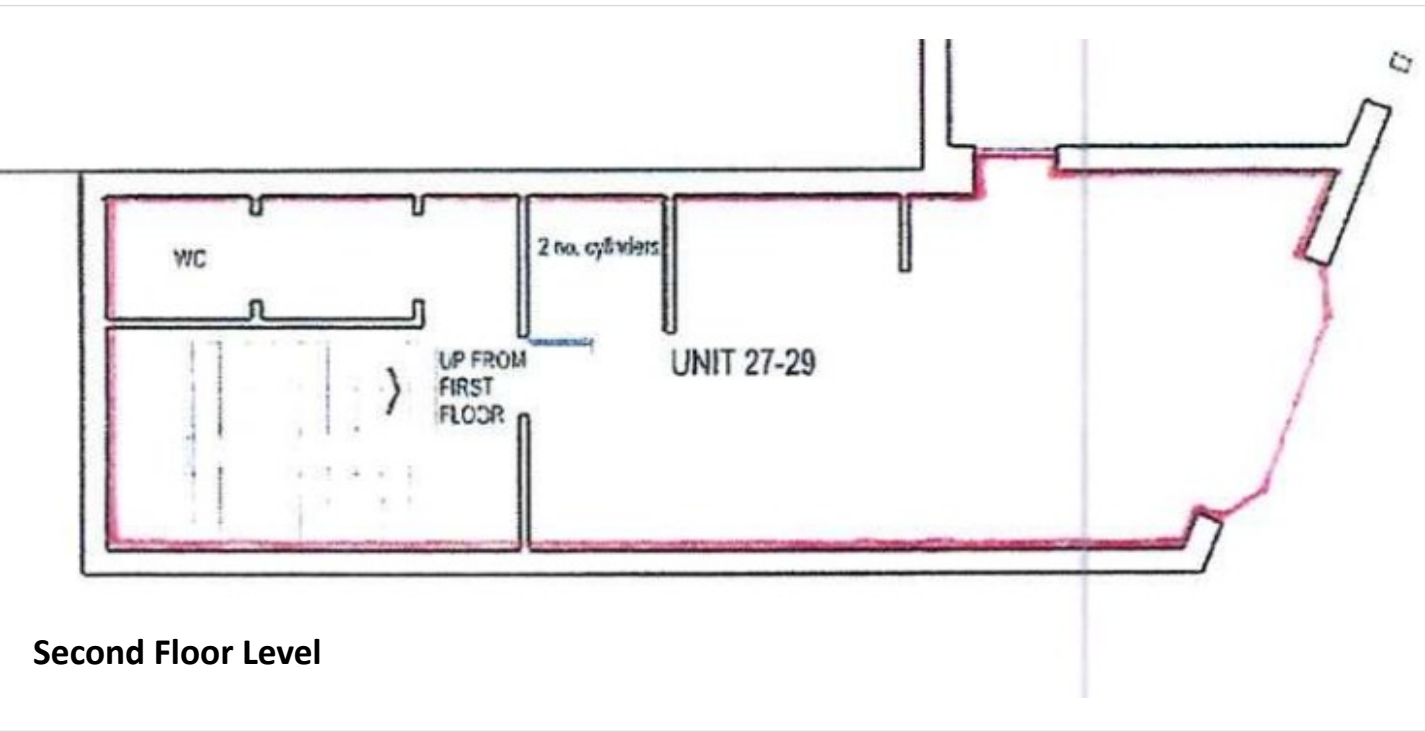
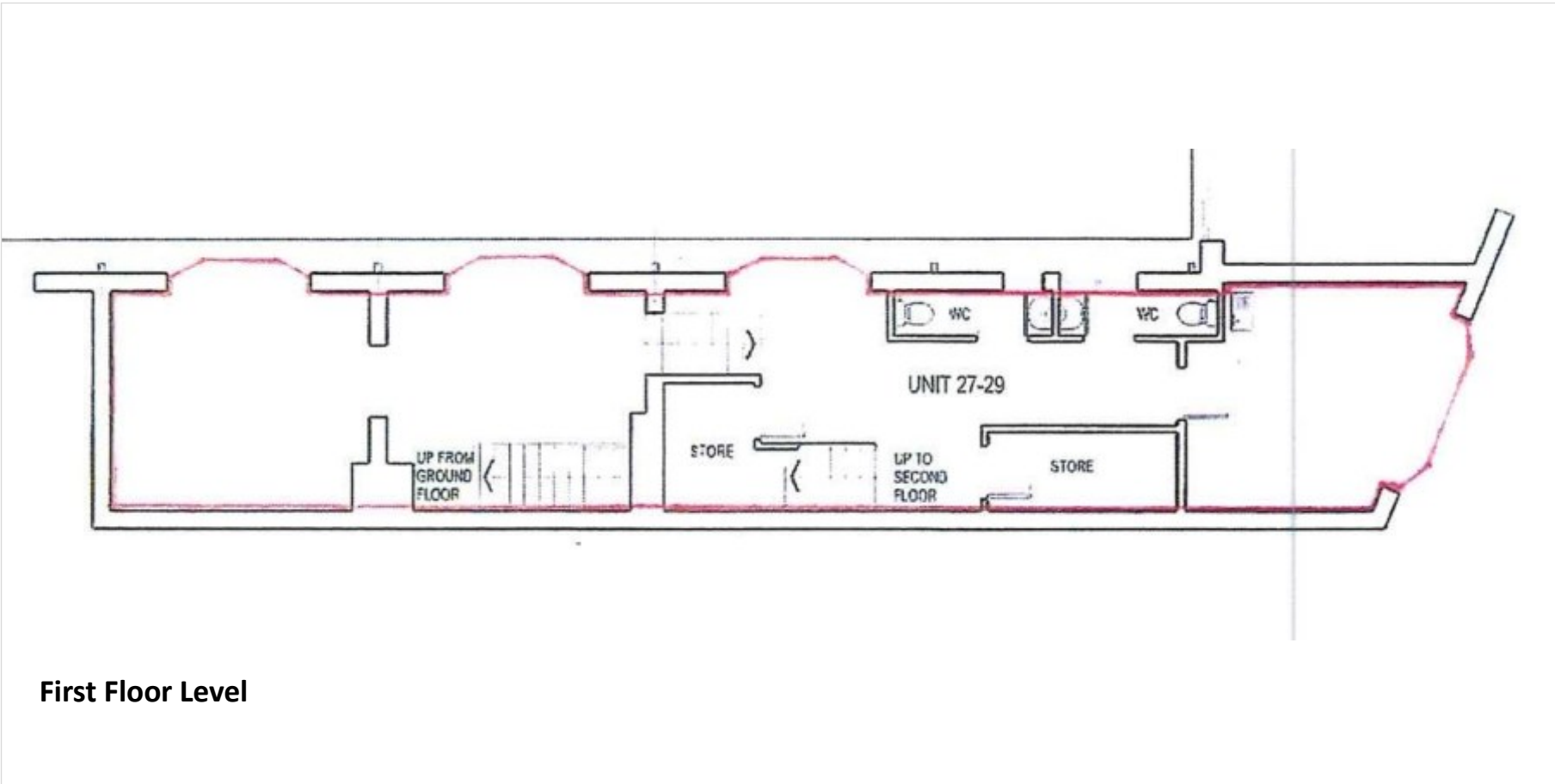
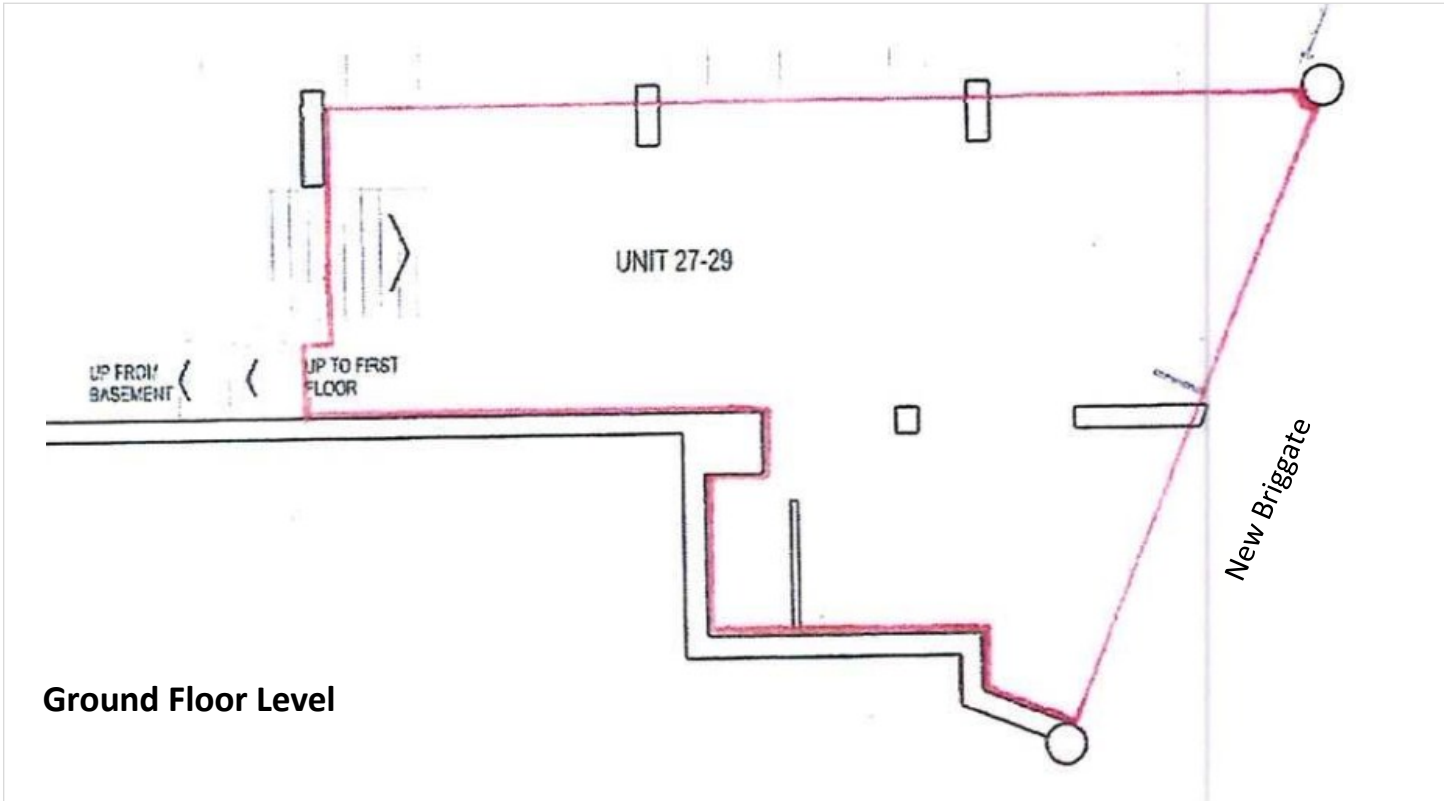
The unit is located fronting New Briggate with great prominence and heavy footfall and traffic movements. The unit has external seating on the pavement area to the front and as is utilised by Brotherhood next door.

The unit is offered as a fully fitted bar. It comprises approximately 1855 square feet (172 square metres) of versatile space, offering a prime opportunity for businesses seeking a well-positioned, self-contained premises. Designed to maximize visibility and customer engagement, the unit features a prominent shopfront with a large display window and a partially glazed entrance door, ensuring an inviting and professional presence.

Close by the LGI have invested £450 million in the Innovation District providing 94,000 sq m of health care facilities, which will bring further footfall to the area. The surrounding high-rise accommodation blocks also house thousands of students, who bring much custom to the locale.

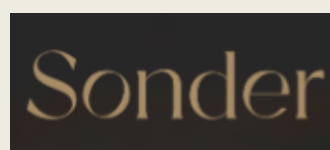
