

Description

The Property comprises a trade counter unit alongside an industrial unit with two roller shutter doors. There are staff facilities and an office between the two units. The doors and windows all benefit from security shutters. The trade counter has a suspended ceiling on the ground floor with a full mezzanine floor above. The trade counter unit has a maximum eaves height of 5m and the workshop has a maximum eaves height of 4m. There is LED lighting. The unit will be refurbished to provide new staff toilets and kitchenette.

There are yards secured with palisade fences either side of the unit and ample car parking at the front of the property.

The main roller shutter door is 3.55 m high x 3.00 m wide and the second roller shutter door which leads to the secure yard is 3.07 m high x 2.10 m wide.

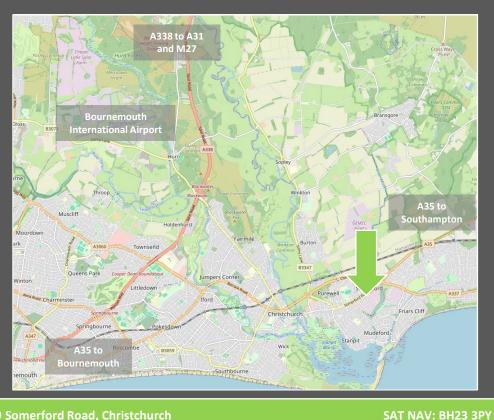
