DESCRIPTION

Unit 5 is an end-of-terrace unit forming part of wider established industrial estate. The unit is constructed of steel portal frame with profiled cladding externally upon part brick/ blockwork and a pitched roof. The warehouse benefits from a clear height of 7m and one level-access loading door. There is first floor office space and a spacious reception area. Externally the unit benefits from a generous yard and large parking area.

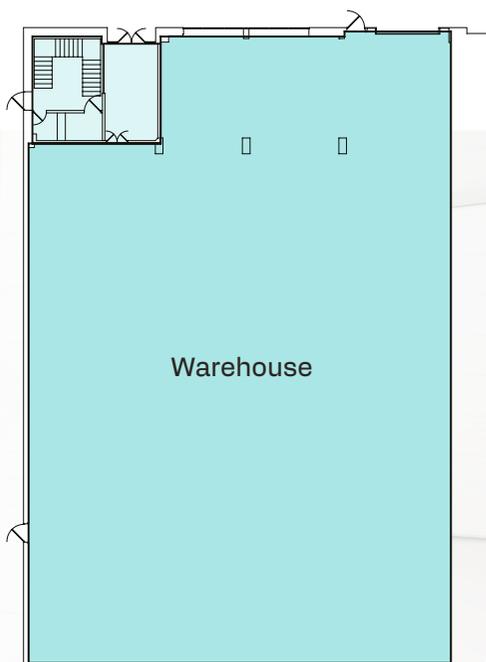

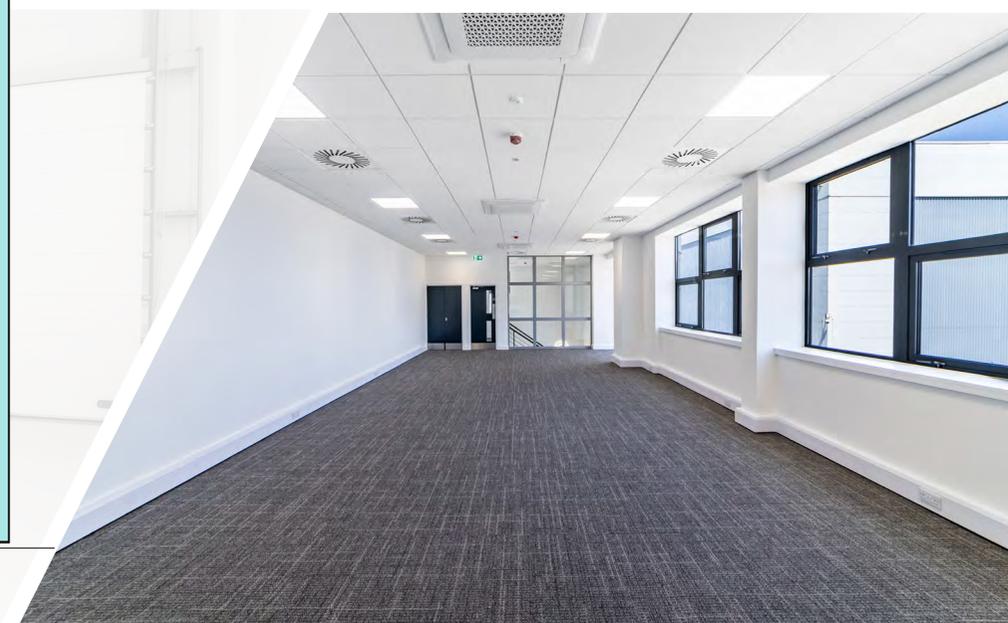

LOCATION

Hemel Hempstead is located in Hertfordshire, about 24 miles northwest of central London. It lies within the commuter belt, offering easy access to the capital via road and rail. The town benefits from strong transport links, including the M1 motorway and a direct train line to London Euston.

The property is located on Eaton Road, in the heart of the Hemel Hempstead industrial area, approximately 1.5 miles from the M1. The M1 provides quick access to the M25 and A41 dual carriageway linking to the A1.

Local occupiers include Next, Atlas Copco, Honeywell, Booker, Selco, Robert Dyas and Royal Mail.

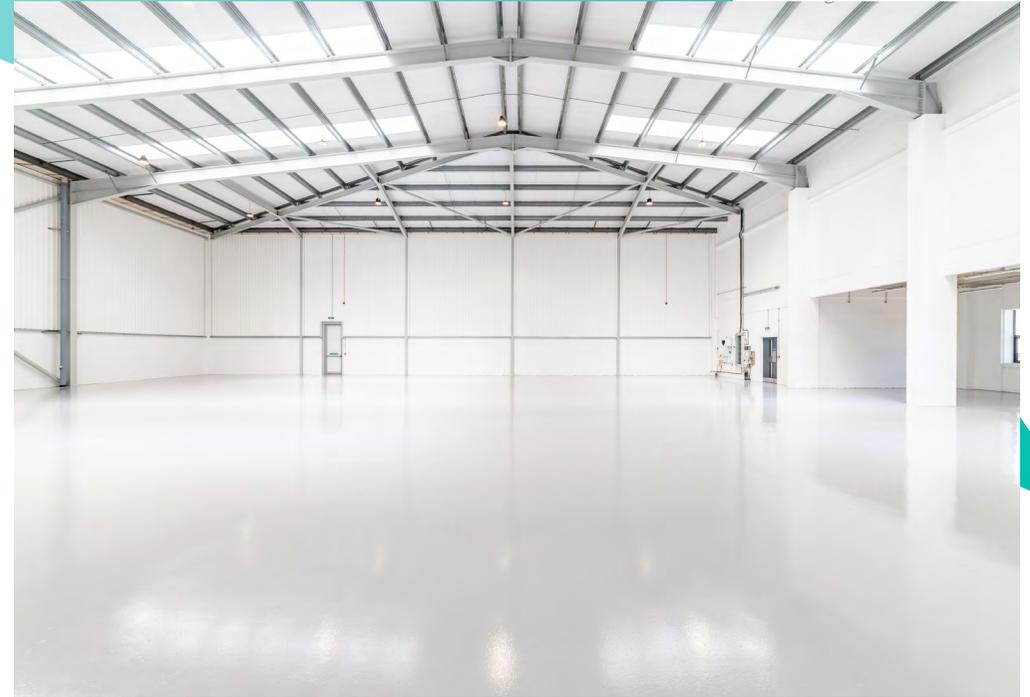
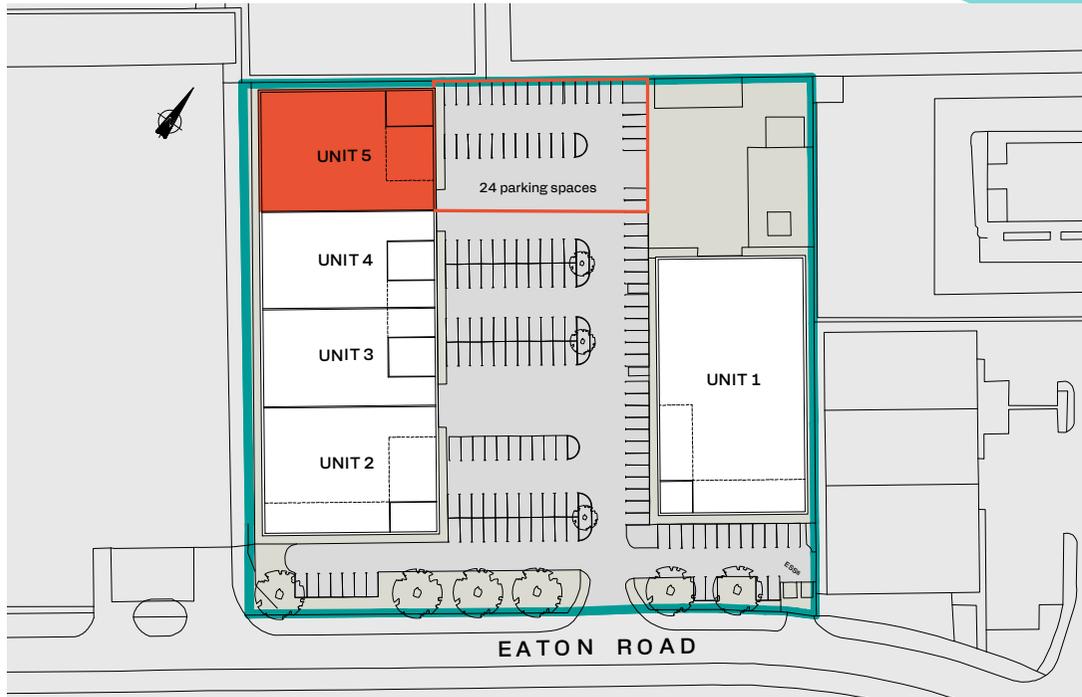

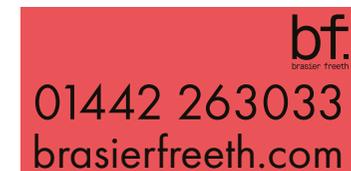
