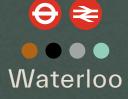

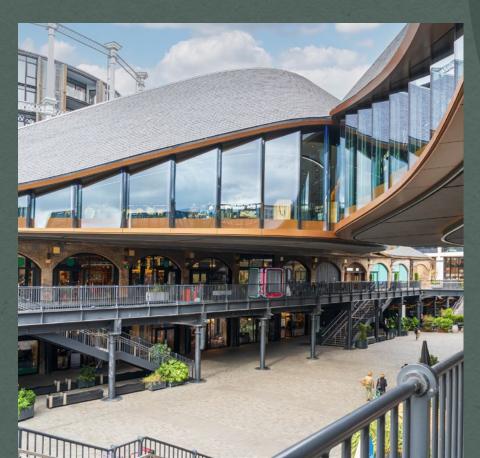

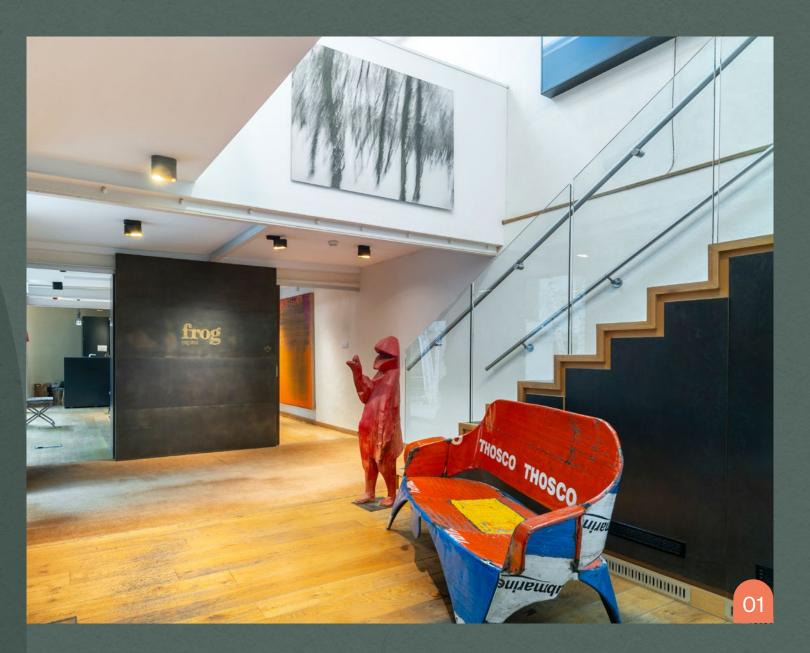
THE BUILDING

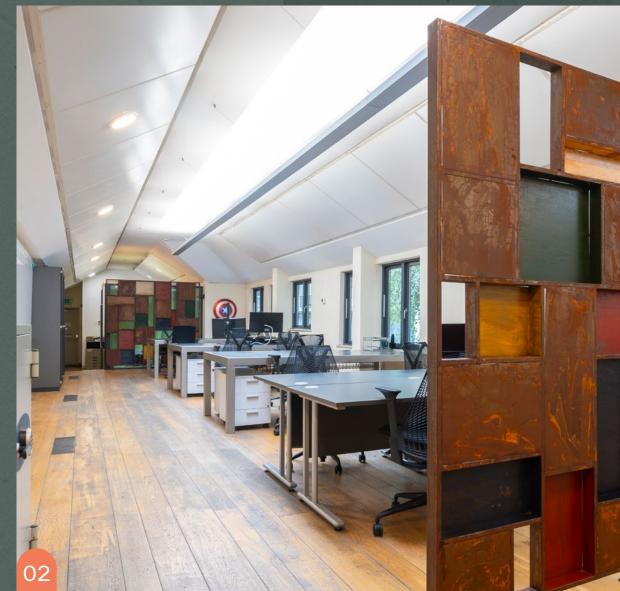
The Mews is a modern office building converted from a Victorian era stables block in a secure courtyard environment.

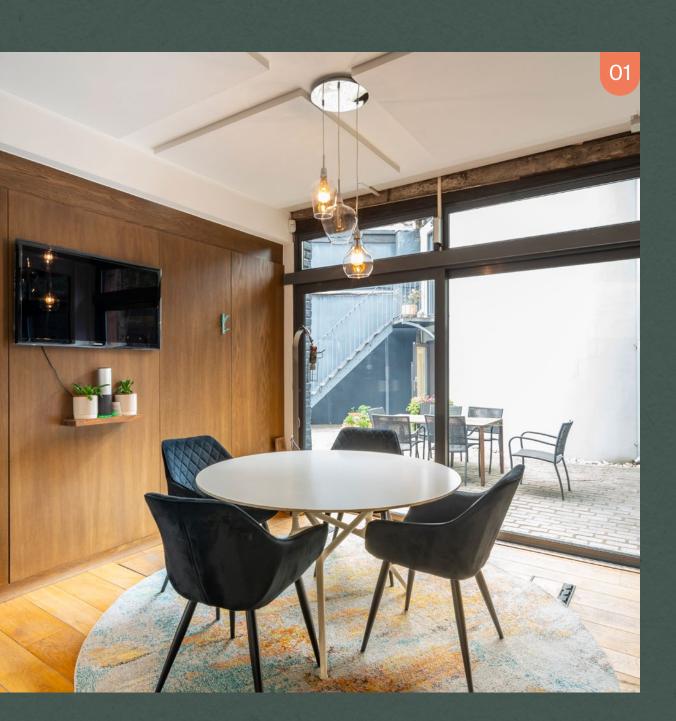

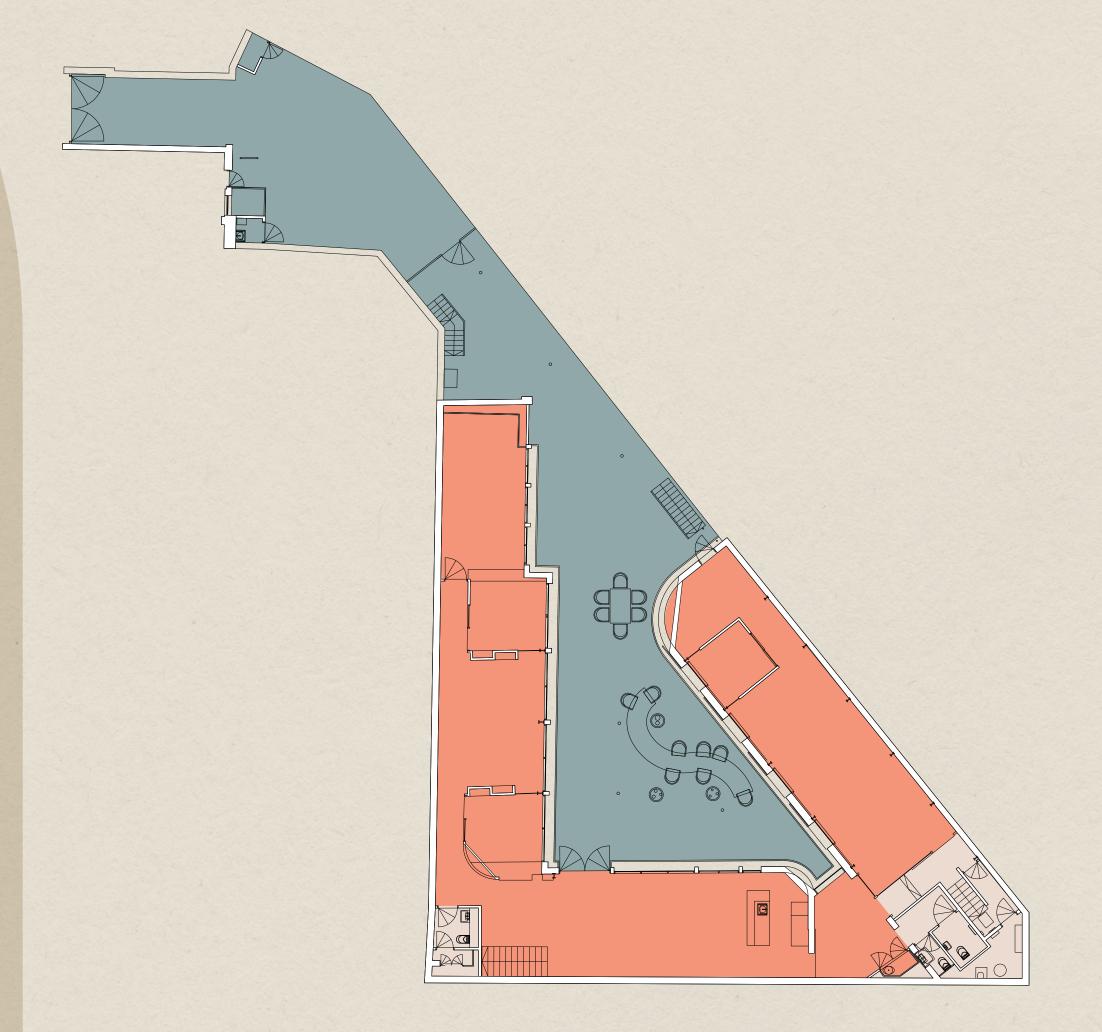

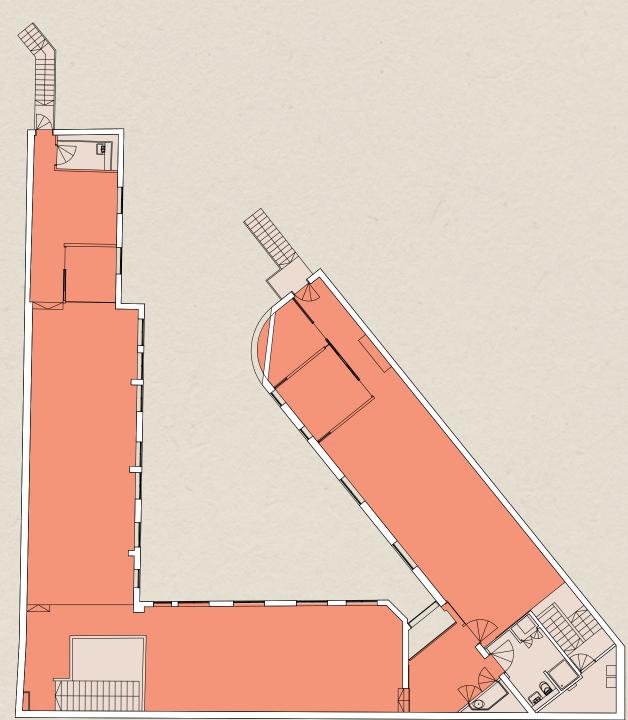
