



## LOCATION

The premises are situated at the northern end of Road One on Winsford Industrial Estate.

The Estate is situated one-mile east of Winsford town centre, just off the A54 Middlewich Road, with access to the M6 at Junction 19 (11 miles to the North East) and Junction 18 (5 miles to the South East).





## THE PROPERTY

The unit is prominently located fronting Road One and is detached, sitting centrally within a regular shaped plot.

- Tarmacadam car park to the front providing approximately 53 spaces

- Insulated metal profile cladding to all elevations and roof
- Approximately 10% roof lights
- High level LED lighting
- Clear internal eaves to 13.5m
- Access via two electrically operated roller shutter doors (5.5m x 5.3m)
- Three phase electricity supply
