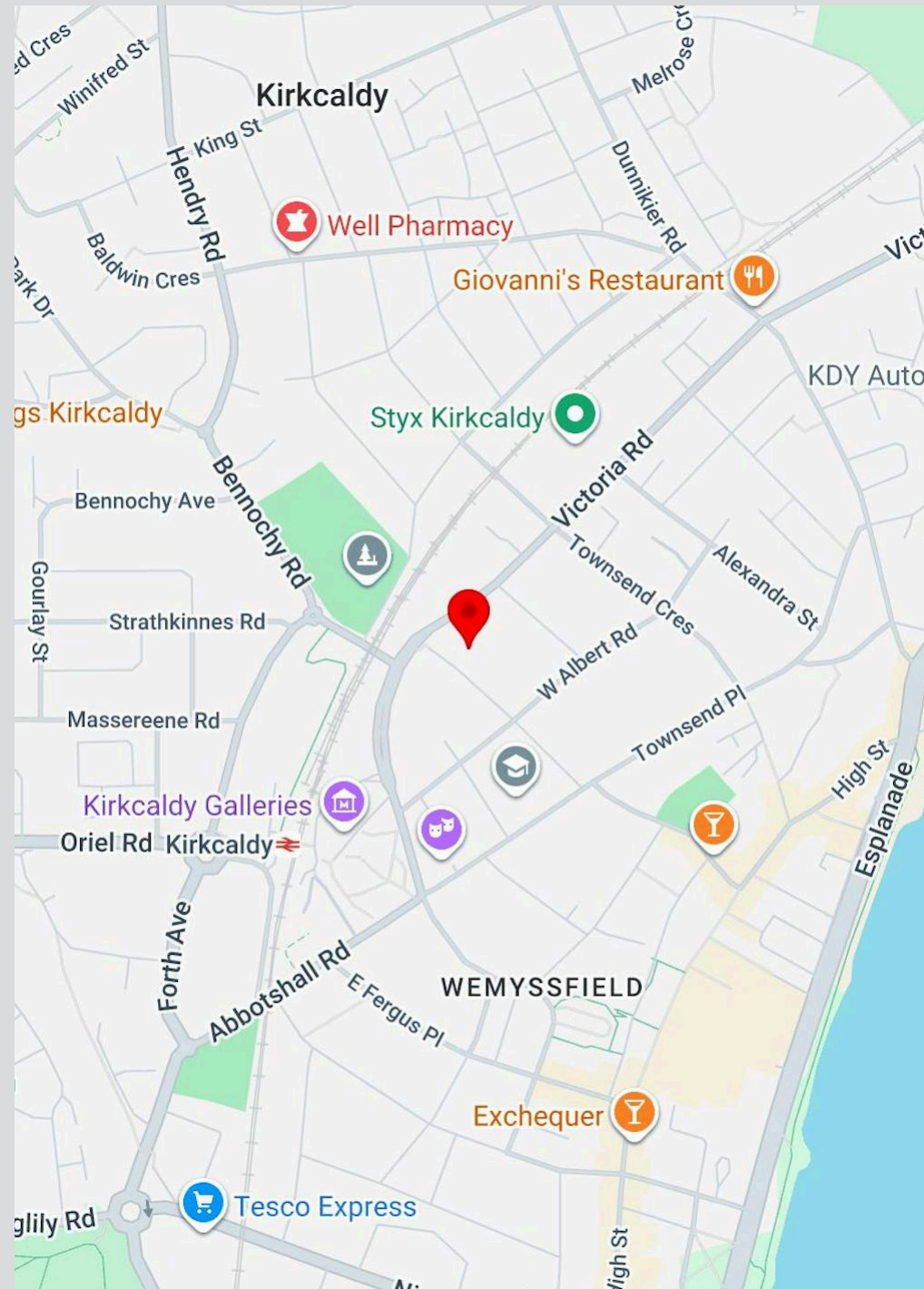
## LOCATION

Notably, Suite B7 holds a dual classification as both a serviced office and healthcare facility, making it particularly well suited to medical, therapy, or wellbeing professionals seeking a discreet and professionally appointed base.

For those requiring dedicated counselling or consultation space, private counselling suites are available from £495 pcm, thoughtfully designed with mood lighting, acoustic wall linings, and soundproofing rated up to 48dB — ensuring a calm, confidential, and professional environment.

All occupiers benefit from an impressive range of shared amenities, including breakout areas, tea preparation kitchens, meeting rooms, and acoustic meeting booths, alongside a planned private gym facility. 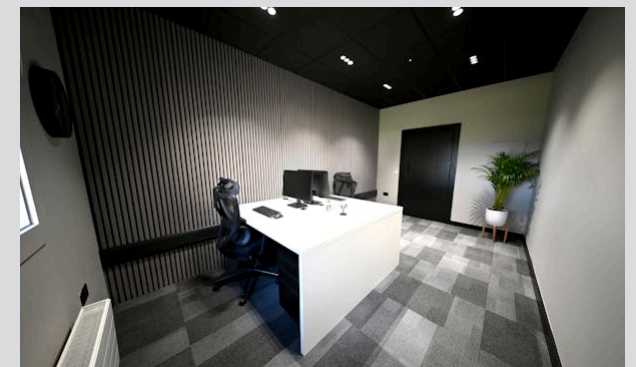
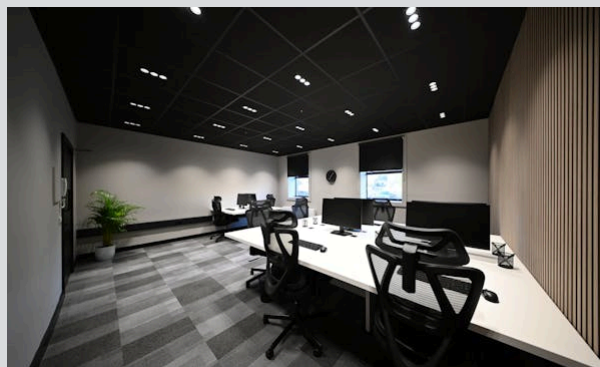

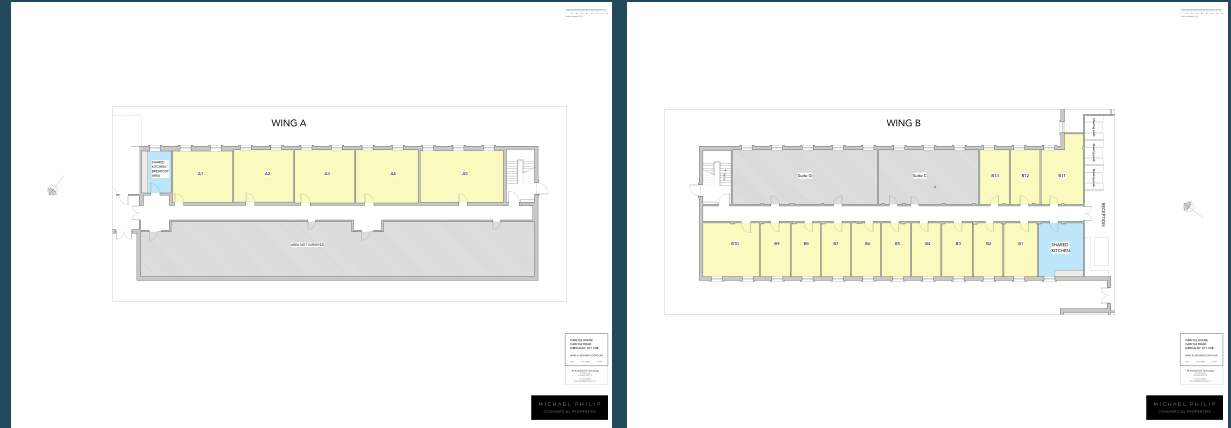
