### Description

The property is a detached warehouse/ industrial unit of steel portal frame construction with clad elevations under a pitched roof.

The property has two larger roller shutter doors and three smaller ones. The property benefits from 9.5m eaves height, large HV power supply, loading canopy, yard, LED lighting, concrete floor and ample onsite parking.

## Location

Unit 7, Stourport Road is situated approximately two miles distant from Kidderminster and Stourport town centres, benefiting from main road access via the main A451 Stourport and Minster Road.

Stourport Road is a well-established trading location with a number of office, industrial and warehouse occupiers. The area is part of the South Kidderminster Enterprise Park being a key area of employment regeneration.

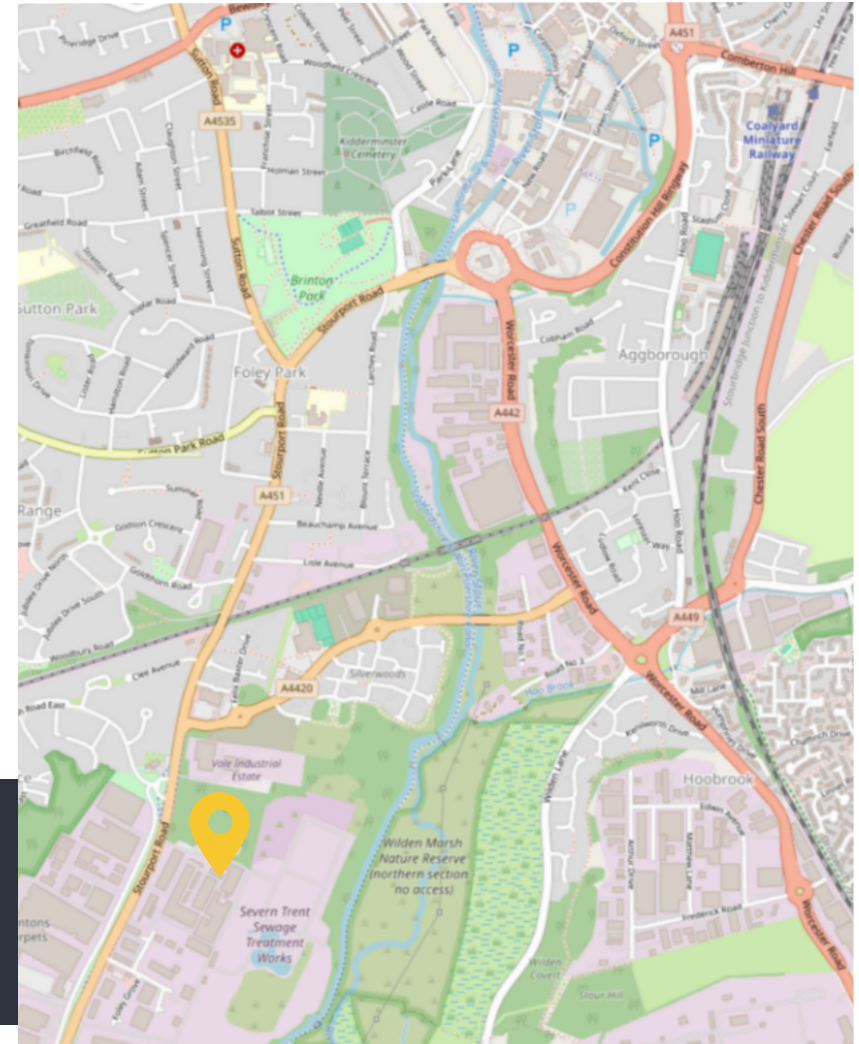
