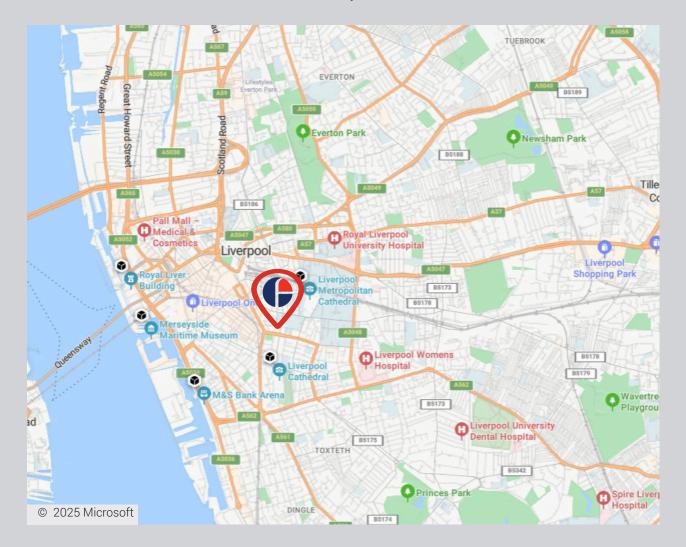






SECOND FLOOR PLAN
