Description

This is a three-storey mid terrace property located in a highly visible position in the town centre of Bedford. The ground floor offers a personnel entrance into the retail / office space which is mainly open plan leading via steps, to a rear office, basement access and lobby with access to a kitchen and WC facilities.

There is an enclosed rear entrance lobby which also provides access to an additional office space.

The first floor of the residential apartment can be accessed through a front shared lobby and the rear lobby area. This comprises a living room, dining room / 3rd bedroom, fitted kitchen, and shower room. The second floor comprises a master bedroom and 2nd bedroom.

The property has gas central heating, electrical safety certificates completed, a new boiler has been fitted and serviced, the ground floor has air conditioning fitted and both the commercial and residential space are separately metered.

The unit has 4-6 parking spaces located to the rear of the property, accessed via Balsall Street East.

Location

The property is located on Harpur Street which is a sought-after location in Bedford town centre housing a variety of commercial outlets including restaurants, hair salons florists etc. Bedford, the county town of Bedfordshire is situated approximately 11 miles from junction 13 of the M1 and within approximately 9 miles of the A1. The Bedford southern bypass, the A421 provides a direct link to the A1, Junction 13 of the M1 and Milton Keynes. The bypass also links with the A603, A600 and the A6 southbound to Luton.




