

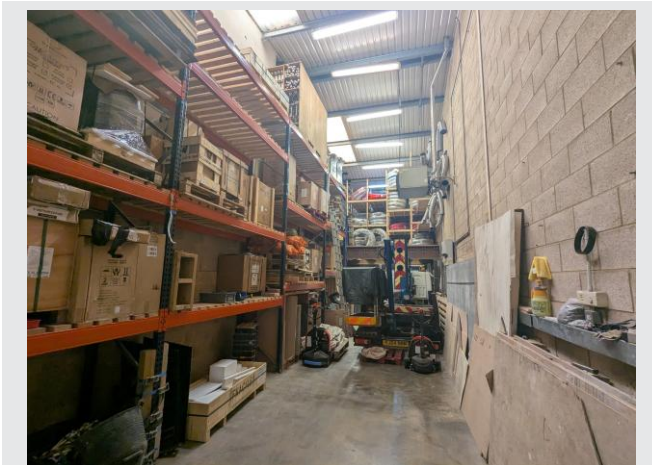
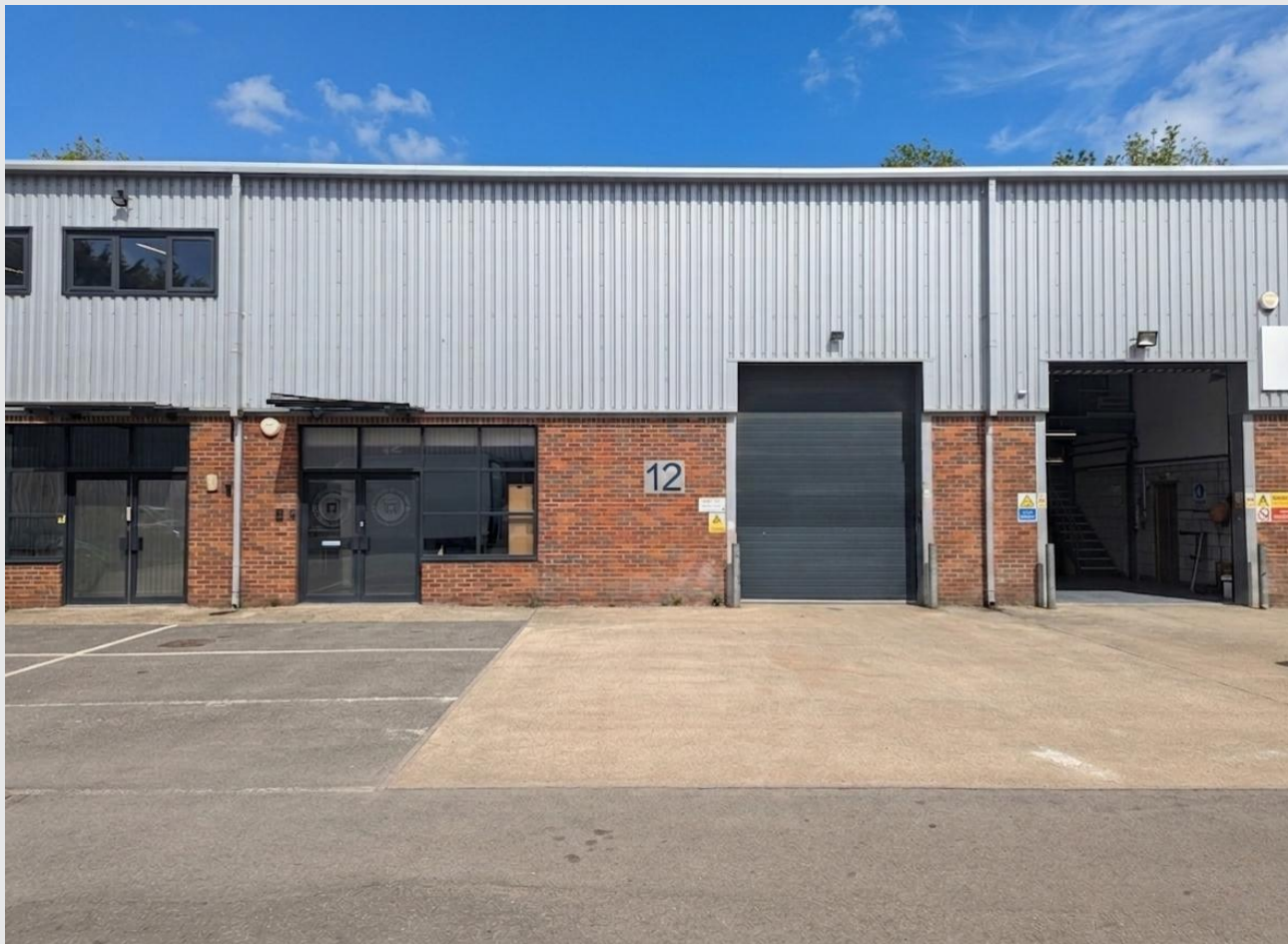

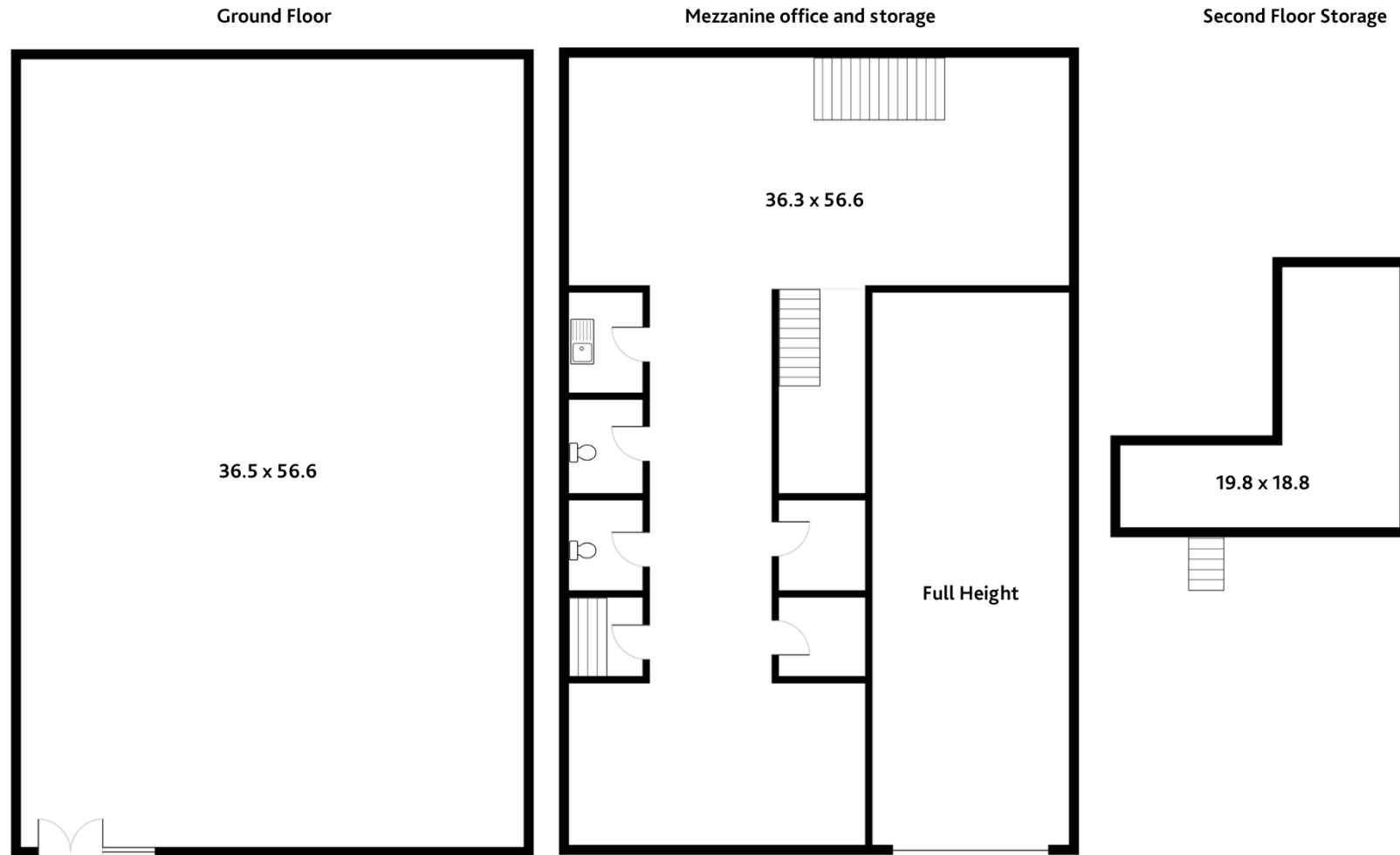

LOCATION

The property is situated to the rear of Anglo Business Park off Ashridge Road, one of the town's principal business and industrial areas. Chesham is strategically positioned to the northwest of London, within close proximity to the regional centres of Watford, Hemel Hempstead and High Wycombe. The area benefits from excellent transport communications via the M25, M1 and M40 motorways, together with strong rail connections to Central London through the Metropolitan Line and Chiltern Railways services.
