Location

Banbury is situated at Junction 11 of the London to Birmingham M40. The town has a population of 42,000 and a catchment of approximately 290,000. Banbury is an expanding town with considerable new housing and commercial developments taking place.

The premises are prominently situated on the B4100 Warwick Road, close to Banbury Cross and within walking distance of Banbury Town centre.

Description

The premises comprise a double fronted brick-built and clad building. The premises are currently used as a furniture showroom and arranged over two floors with additional car parking facilities.

The site has excellent potential for redevelopment and conversion to residential uses, subject to the usual building and planning consents.

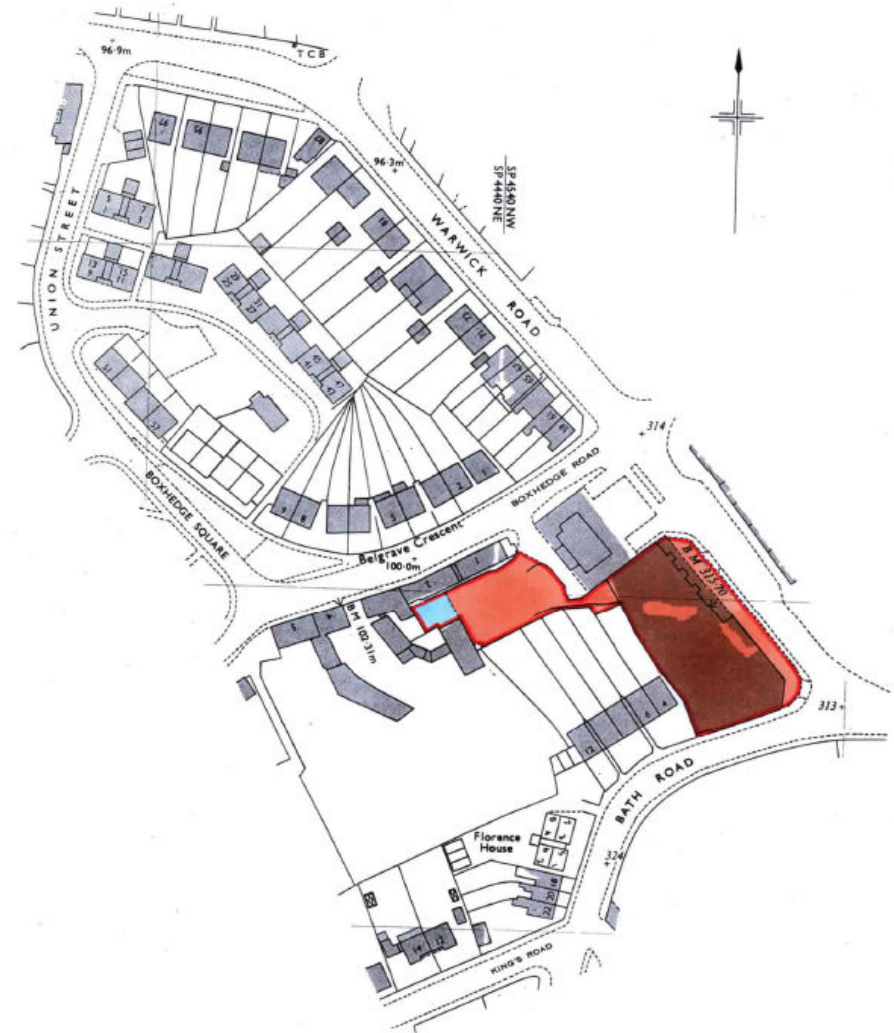
Planning

The Cherwell Local Plan 2011-2031 - Part 1 was formally adopted by Cherwell District Council on 20th July 2015 and provides the strategic planning policy framework for the District to 2031. The Local Plan 2011-2031 – Part 1 replaced a number of the 'saved' policies of the adopted Cherwell Local Plan 1996 though many of its policies are retained and remain part of the development plan.

In Cherwell, a five-year housing land supply does not presently exist. The Council's latest Annual Monitoring Report (AMR 2021), prepared in accordance with the NPPF guidance (National Planning Policy Framework - revised on 20 July 2021) identifies only a 3.5- year housing land supply for the period 2022-2027 (commencing on 1 April 2022). As the Council cannot demonstrate a five-year housing land supply, in accordance with the NPPF, any assessment of residential proposals, states that planning permission should be granted unless any adverse impacts of doing so would significantly and demonstrably outweigh the benefits when assessed against the policies in the adopted Cherwell Local Plan 2011-2031 and the NPPF taken as a whole. Whilst the site is not allocated for development, it is located within a sustainable location within Banbury. It is considered that development of the site will be in accordance with Policy BSC1 in terms of the delivery of housing and would accord with Policy BSC2 being brownfield land and would therefore also be in accordance with the Local Plan Objective SO12, which seeks to focus new development in sustainable locations.

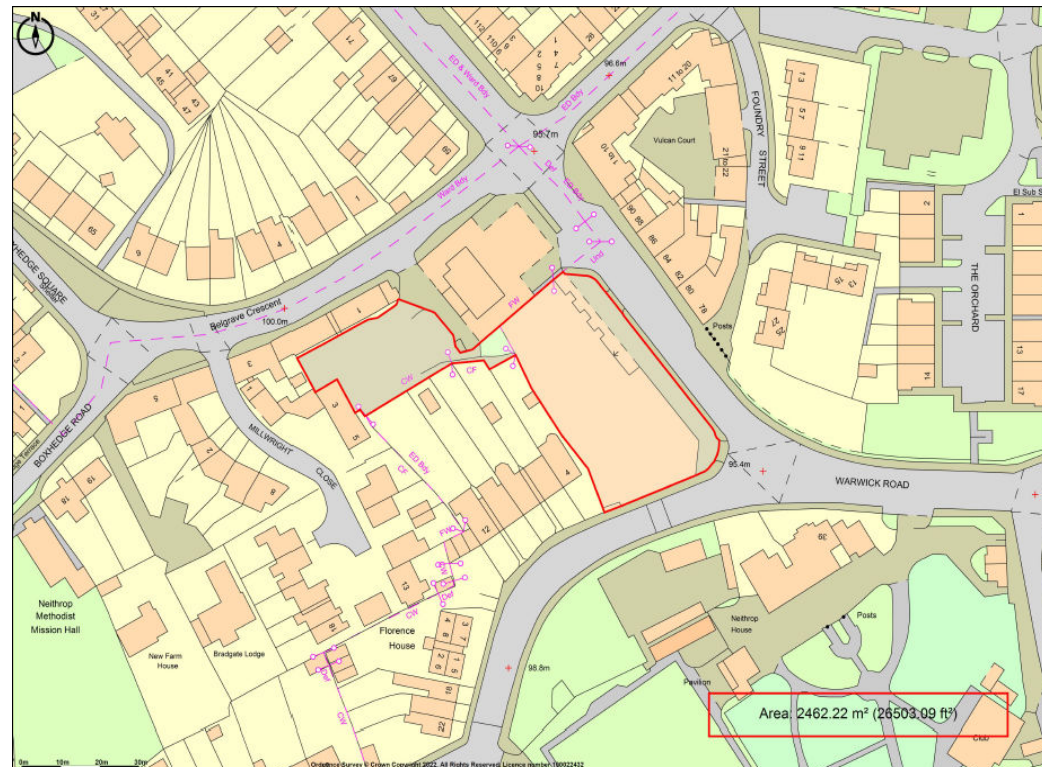
