Location

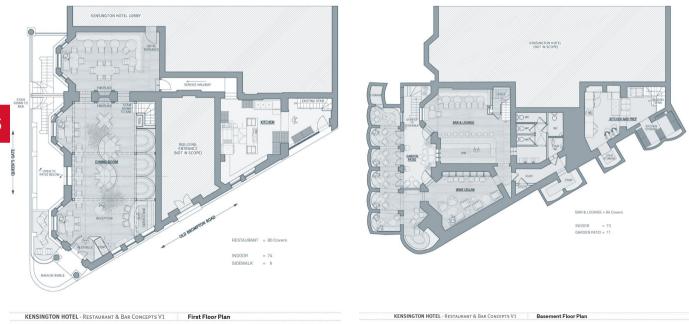
