Location

Brighouse is a historic market town in the borough of Calderdale located 5 miles north of Huddersfield, 4 miles north east of Halifax and 9 miles west of Dewsbury.

The site is situated within an established residential area fronting Toothill Lane, connecting to Huddersfield Road (A641). Providing direct access to Brighouse town center. Toothill Lane is situated midway between junction 24 (2.8 miles) and junction 25 (2.4 miles) of the M62.

Brighouse railway station is a 2 minute drive (1 mile) from the site which provides access into Halifax in 20 minutes, Huddersfield in 25 minutes and Leeds city centre in 1 hour.

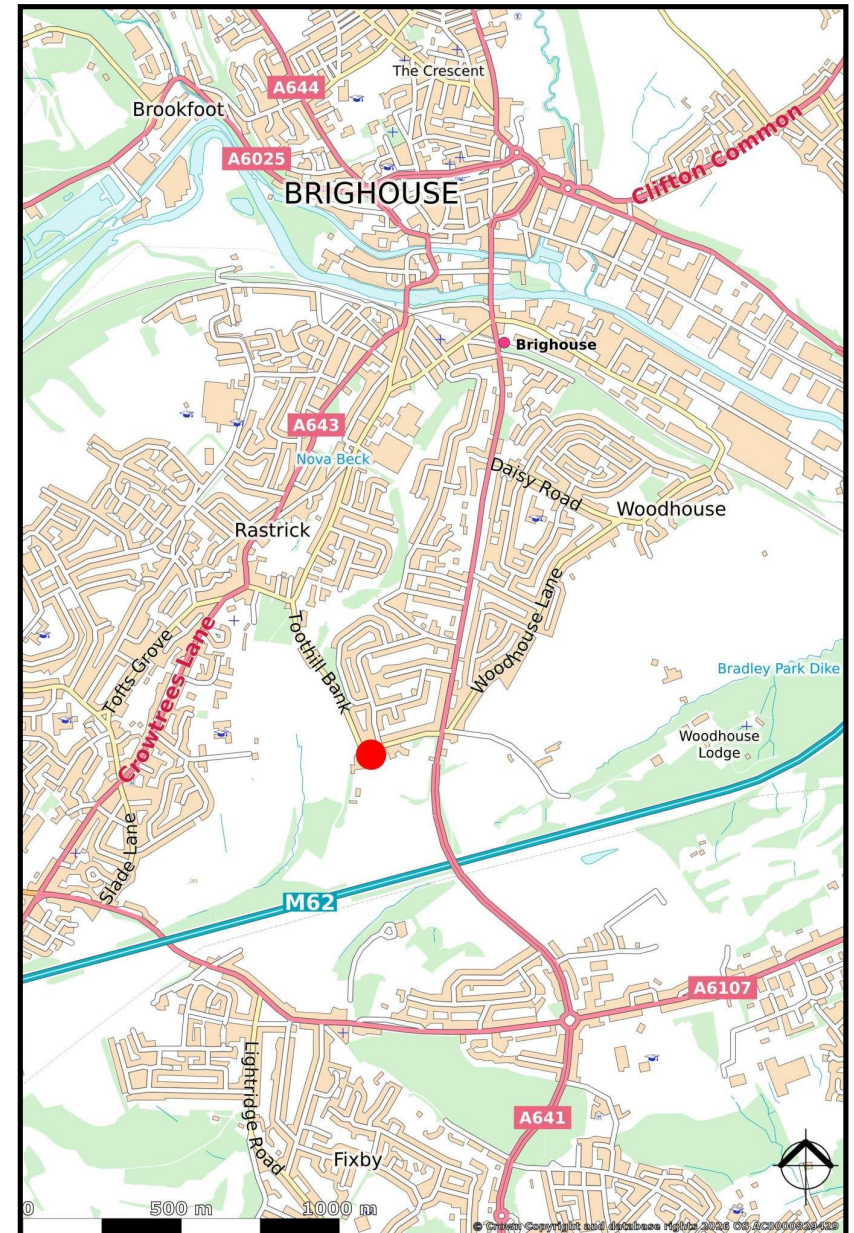
The Site

The site extends to approximately 0.96 acre and is irregular in shape. It comprises a number of residential and agricultural buildings situated on areas of hard standing, together with associated green space

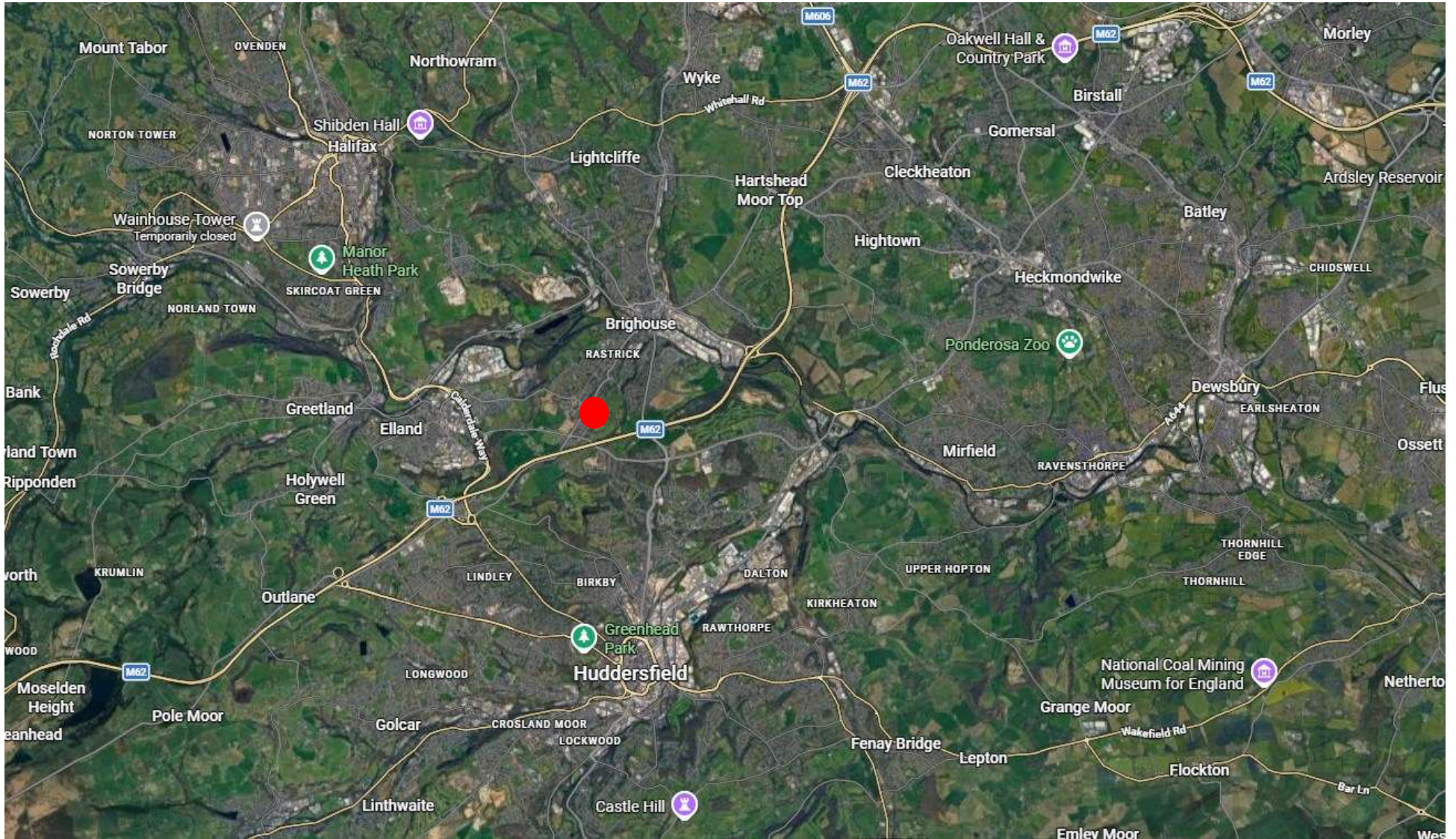
