The A4036 gives direct access to Dudley town centre and Junction 2 of the M5 Motorway. The M5 Motorway is easily accessible, with Junction 2 approximately 6 miles away.

Stourbridge town centre lies approximately 3 miles to the south west of Dudley approximately 4 miles to the north east. Birmingham is approximately 13 miles to the east.

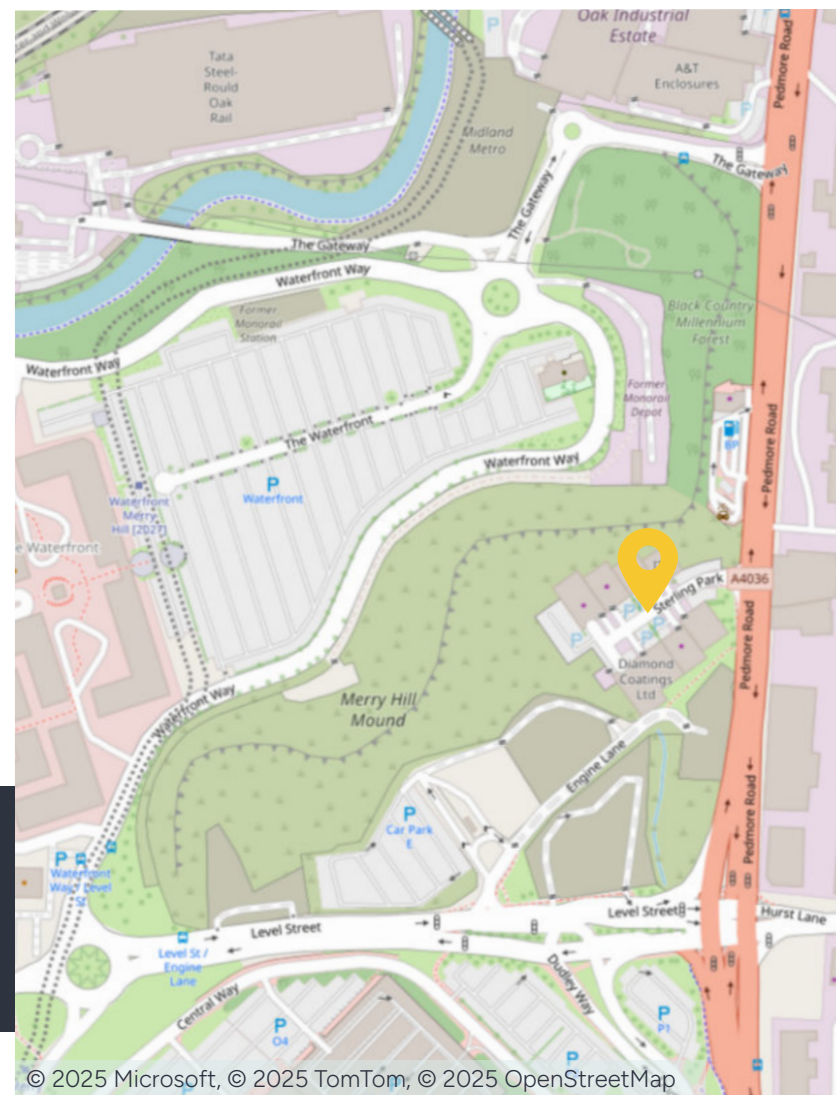
