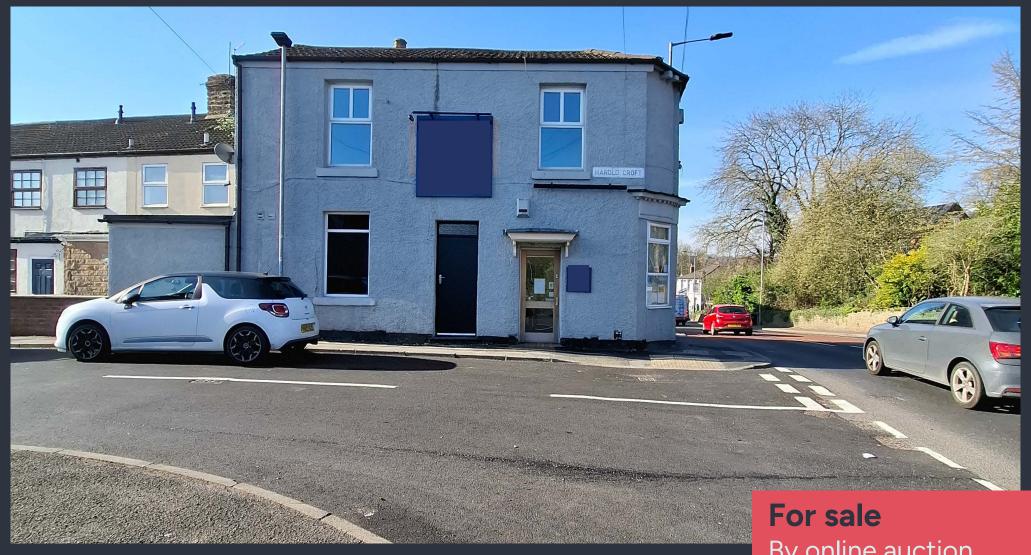

Description

The property comprises a former funeral director's on the ground floor with first floor separate access flat. The property is of brick structure with painted rendering, under a pitched roof. Access to the property is via Harold Croft Road with separate entrance to the first floor.

Internally, the ground floor comprises reception room, office, two chapels of rest, consultation room and storage space. The property is neutrally decorated with plaster painted walls, carpet flooring and gas central heating throughout. The property also benefits from a basement, which is currently left in shell condition. uPVC glazing and drainage is fitted all through the building.

The first floor flat comprises of two bedrooms, kitchen area and bathroom and requires refurbishment throughout.

Externally, there is a tarmacked yard area which is accessed via Main Street. The site benefits from a large detached double garage and car parking for approximately 3-4 cars.

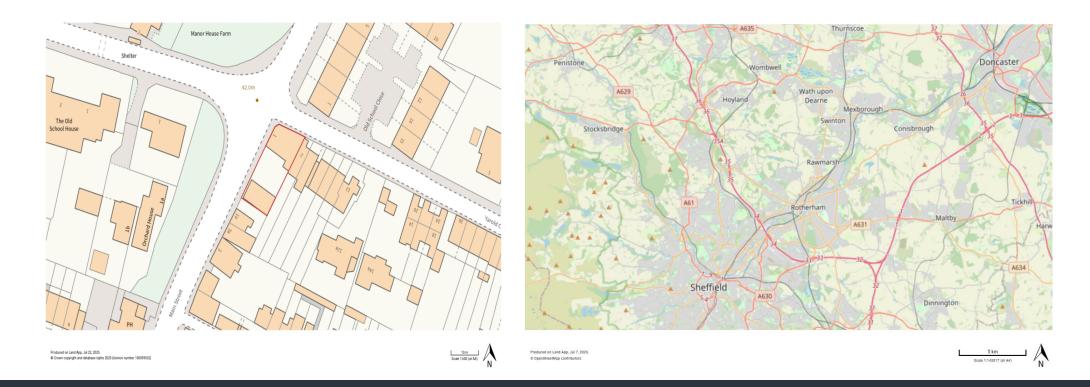
Location

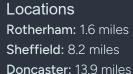


The property is located on the corner of Main Street and Harold Croft in Greasbrough, Rotherham and has a population of 7,786 people.

Main Street meets Car Hill south of the property, the main route connecting Greasbrough and Rotherham town centre. The area is primarily residential with several other independent businesses also located on Main Street, including hairdressers, barbers and convenience store.

Greasbrough is located approximately 1.7 miles north of Rotherham town centre, 11.5 miles north of Sheffield and 14 miles west of Doncaster. Rotherham train station is approximately 2.2 miles from the property which also lies a short distance from several motorways, for wider UK access, including M1 4.4 miles south of the property and the M18, 19 miles east.
