Unit 9 provides a functional industrial/warehouse unit of 5,739 sq ft, together with up to 1 acre of secure hardstanding (which could be let separately). There are 4 loading doors, canopy area of approximately 1,380 sq ft, 3-phase electrics, high bay lighting with eaves height of approximately 5 metres.


Located within a 4.94 acre site, with good parking and 3 phase electric, Hayloaders Works provides economical accommodation. The whole site comprises 4 single storey industrial/storage buildings of steel frame construction & separate office building. Formerly used as a saw mill for 25 years & assumed has established/authorised use for B1, B2 & B8 under 1987 Use Classes Order.
