### LOCATION

The historic town of Greenwich is a thriving town centre and visitor destination, set in a World Heritage Site and home to the National Maritime Museum, the Cutty Sark, the Royal Observatory, Greenwich Park, and the University of Greenwich. It features a vibrant and eclectic mix of shops, restaurants, cafes and pubs as well as the popular market. With a mixture of local and London residents, domestic and foreign tourists, the area sustains a strong level of footfall all year round.

Nelson Road is a key thoroughfare for eating and drinking in Greenwich, home to Sticks n Sushi, Rosa's Thai, Honest Burger and Gail's Bakery, amongst others. The property is located on the north side of Nelson Road by the entrance to the Market, close to Honest Burger and Dark Sugars, as well as Jimmy Fairly, Sticks n Sushi, and Rush Hair & Beauty. Cutty Sark DLR station providing services to the City of London and Canary Wharf is with 0.3 miles.

### DESCRIPTION

The property comprises a double retail unit based over ground and basement levels. The premises benefits from a large return frontage, good natural light, laminate flooring, spotlights, electric supply only (no gas), and WC facilities.
