### Location

Moordown is busy and popular suburb approximately 2.5 miles to the north of Bournemouth Town Centre. The area is an established retailing location and there are an array of national, regional and local retailers as well as coffee shops, cafes, restaurants and professional/financial service providers.

The retail offerings supports the densely populated residential area which also plays host to a number of students attending Bournemouth University.

Moordown adjoins the Bournemouth suburb of Winton where there is a large shopping facility spread along Wimborne Road. There are a number of nationally known multiples represented including Coffee #1, Wetherspoons, Iceland, Loungers, G&T's World of Cards, Waitrose, Lidl, Card Factory and Specsavers.

## **Description**

This substantial mixed use property is currently located on a large site area of 0.176 acres. To the front of the site there are 2 good size ground floor retail units. On the first floor there are 2 flats which are both individually accessed. The first flat is one bedroom, providing a kitchen, lounge, bedroom and shower room with WC. The second flat is two bedroom, with kitchen, bathroom, reception room, living room and 2 x bedrooms. To the rear of the site there are a number of industrial style buildings which provide substantial ancillary storage. 3 of these have pitched roofs with the buildings to the front of the site all having flat roofs.

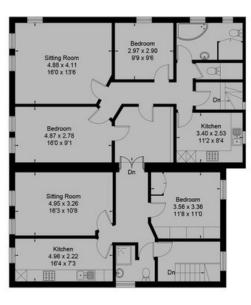
#### ANTI MONEY LAUNDERING REGULATIONS
