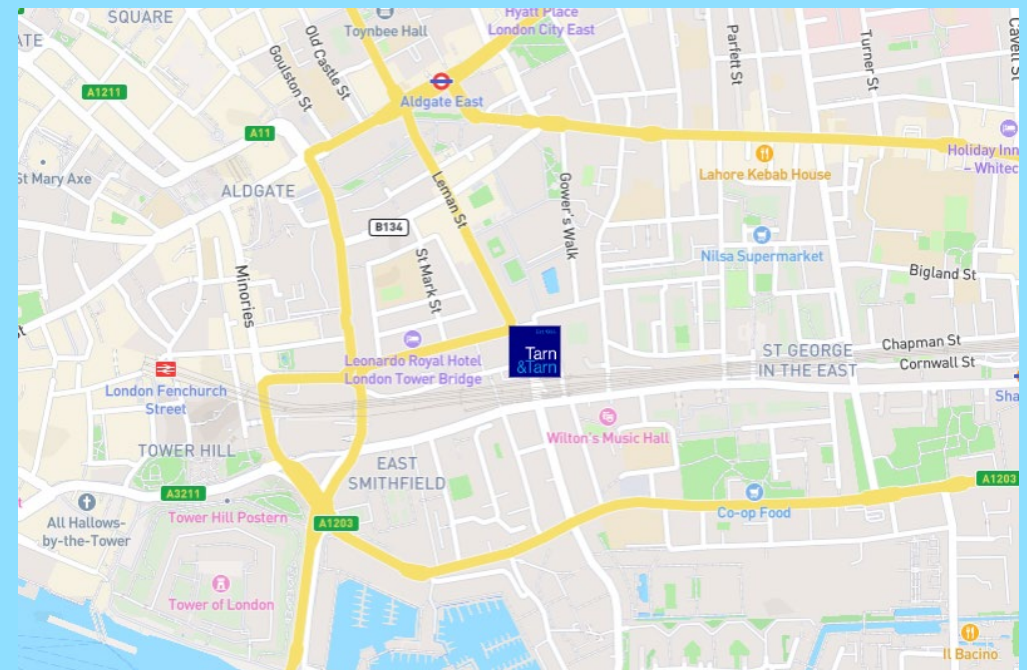
THE AREA
