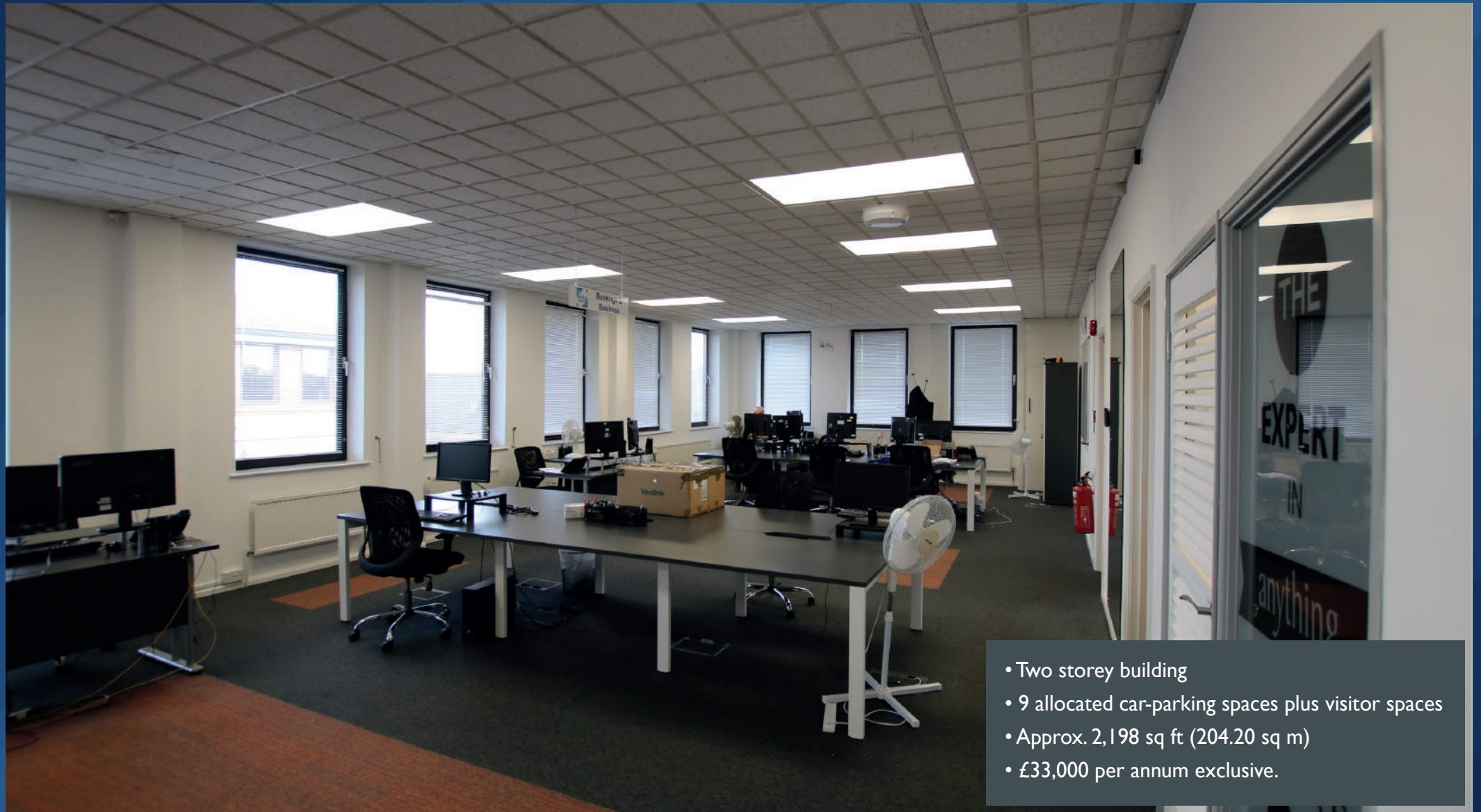

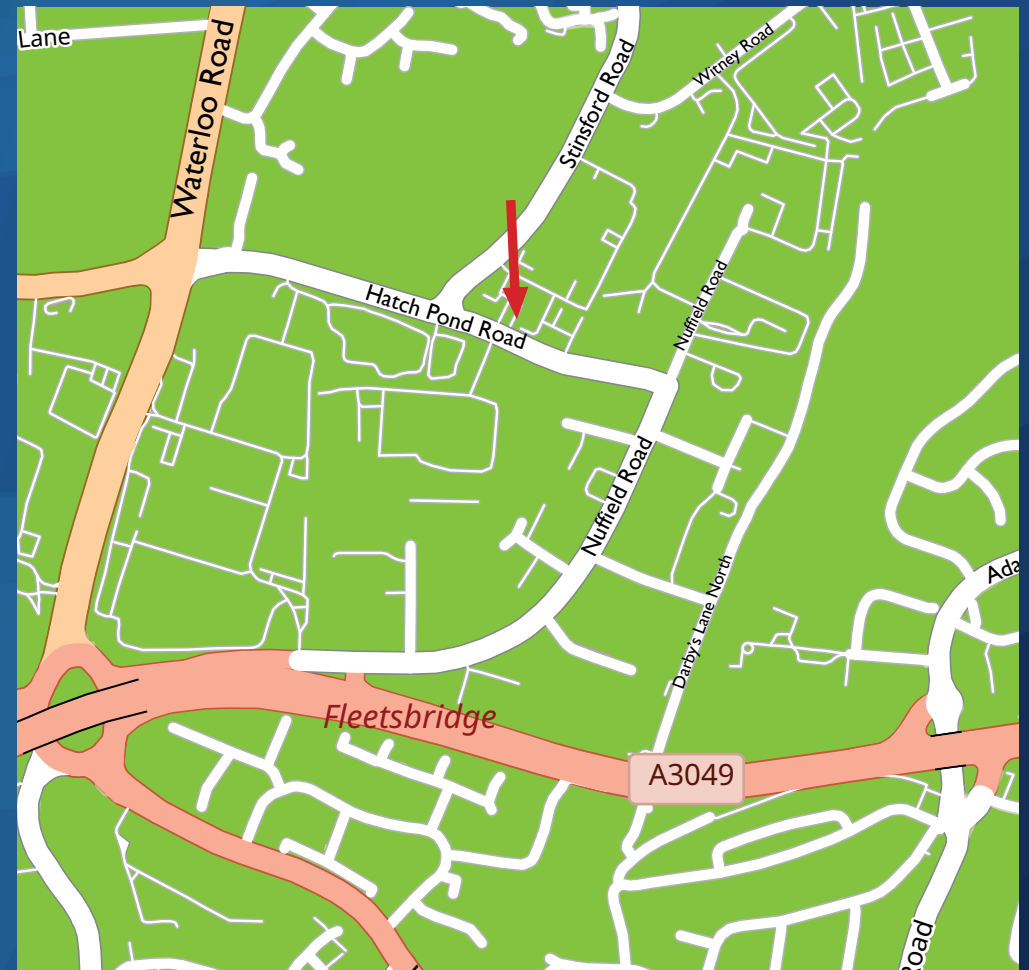
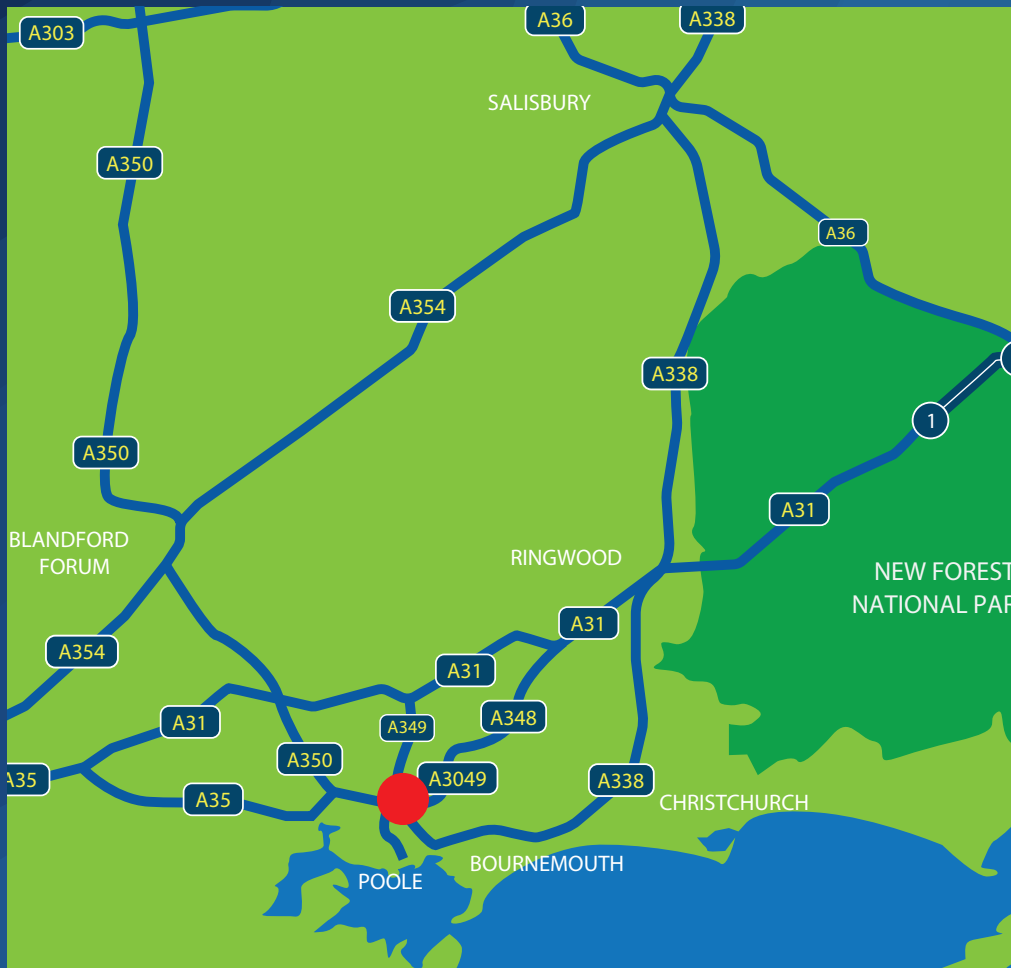

LOCATION

New Fields Business Park is situated at the junction of Stinsford Road and Hatch Pond Road on the edge of Nuffield Industrial Estate, Poole. The development is situated approximately 2.5 miles north of Poole Town Centre and approximately 6 miles from Bournemouth Town Centre. The Fleetsbridge Interchange, which provides excellent access to the A35 Dorset Way dual carriageway, is approximately 1 mile from the Business Park.

DESCRIPTION

New Fields Business Park is a development of 15 office buildings constructed in the early 1990's.

Unit 15 is a self-contained, two storey building which is of traditional brick construction under a pitched tiled roof. The accommodation has partitioned offices on the ground floor and are open plan on the first floor. The property benefits from the following specification:
