Location

Centurion Park is well located on Kendal Road in an established commercial and residential area approximately two miles north of Shrewsbury Town Centre with good access to the main road network.

Shrewsbury is the historic County Town and main administrative centre of Shropshire strategically located at the intersection of the main A5 and A49 trunk roads approximately 12 miles west of Telford, 45 miles North West of Birmingham and 45 miles south of Chester.

Description

Constructed in 2020 the property comprises a high-quality mid terrace trade counter/warehouse unit providing spacious open plan accommodation of approximately 1,840 sqft (171 sqm) with an internal eaves height of 7 metres. The accommodation is configured internally to provide a large open plan warehouse with overhead LED lighting and electrically operated roller shutter door with integral reception, office and toilet facilities.

In addition, the property benefits from 4 on-site car parking spaces.

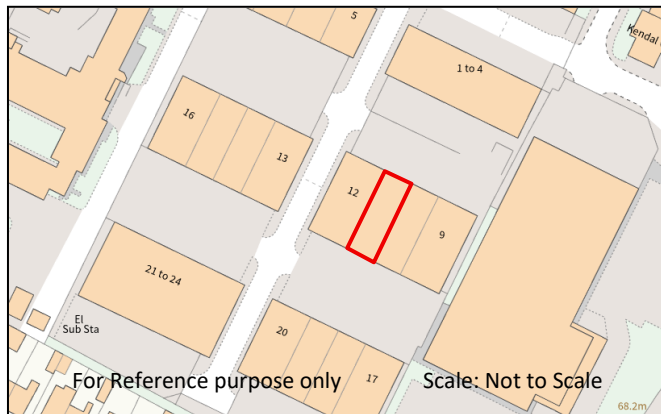
