






## THE LOCAL AREA

42 Newstead Road is located between Hither Green and Lee in southeast London. Immediately adjacent to St Winifred's, a Roman Catholic Primary School, the Property is located in a quiet, leafy, residential road.

Hither Green and Lee offer a range of cafes, shops, restaurants and Victorian pubs alongside some outstanding schools to provide a range of everyday amenities. There is also access to many green spaces including the much-loved Manor House Gardens.

The Property is located circa eight minutes' walk from Lee Station (Operated by Southeastern) and circa twelve minutes' walk from Hither Green (Southeastern) both in Zone 3. Both Hither Green and Lee provide services to London Bridge; Waterloo East, Charing Cross and Cannon Street with varying journey times of 12-25 minutes.

Local bus services are accessed via St Mildred's Road (The South Circular); Burnt Ash Road and Southbrook Road all of which are within ¼ mile of the Property. The Property is located within the extended ULEZ Zone. Please note the Property is also located within a school street where immediately in front of the Property between Monday – Friday and the hours of 08:15-09:15 and 14:45 – 15:45 the road is classified as a school zone which limits access to pedestrian and cycle access only.



## TRANSPORT AND CONNECTIVITY

### **BY RAIL**

The Property is 0.7 miles from Hither Green train station a 15-minute walk from the property. Lee Station is 0.6 miles from the Property and a 8-minute walk. Both stations provide direct trains to London Bridge in 15 minutes; London Cannon Street in 22 minutes with both stations providing London Underground Services via the Jubilee, Northern, Circle and District Lines.

CANNON STREET......22 MINUTES




### **BY ROAD**

The Property is located just within the extended ULEZ Zone and benefits from excellent road connectivity with the A205 (South Circular) just five minutes away. Local bus services are within walking distance providing access to, Lewisham, New Cross, Blackheath, Grove Park and Bromley.

### **BY AIR**

London City Airport is 6.3 miles away and accessible in approximately 40 minutes by car. City Airport offers direct flights to over 30 destinations in Europe.



## **DESCRIPTION**

The Property is rectangular in shape and extends to 0.34 ha (0.84 acres). The Property is arranged as  $12 \times 1$  bed self-contained supported living flats.


The Property is a detached purpose-built facility and extends to 807 sq. m (8,687 sq. ft.) GIA. set out across ground, first and second storey accommodation. The Property benefits from eight off-street car parking spaces located to the front of the building. The front garden also contains two brick bin stores. To the rear is a large communal garden.

The ground floor consists of an entrance hall and two x self-contained 1 bed flats to the front and a communal kitchen; sitting room; two staff offices and communal toilets.


The first and second floors benefit from the same layout and consists of five x 1 bed self-contained flats which provide each resident a kitchen, sitting room, bedroom and bathroom.

The Property benefits from a lift to access the upper storeys as well as a central staircase.


The Property benefits from gas central heating.
