



For Sale - Prominent Town Centre Retail Opportunity with Development and Asset Management Potential

Situated in a prime position on Bridgnorth's busy High Street, this prominently located shop offers a strong commercial prospect in one of the area's popular towns. The property provides a substantial ground-floor, with a Total Net Internal Sales Area of 1,611 sq ft (149.66 sq m) across the ground and upper floors, with excellent visibility and footfall.

The building also offers significant development and asset-management potential, with upper floors suited to a variety of future uses - subject to statutory consents. This is a rare chance to secure a centrally located property with considerable scope to unlock further value from development.

65 High Street

The property provides an attractive three-storey grade 2 listed property, which is of traditional brick construction with element of timber framework under a tiled roof cover and a ground floor fully glazed shop front. The property provides a Total Net Internal Area of 4,348 sq ft (4034 m sq) arranged over the ground floor, first and second floors (excluding the third floor and basement areas).

The property is arranged to provide; a ground floor lock up shop with ancillary facilities on the upper floors, which has significant development potential.

The property has a Total Site Area of approximately 0.177 acres (0.072 hectares), and benefits from a garden to the rear, which may be available for purchase separately by separate negotiation. All car parking is on street.



Location

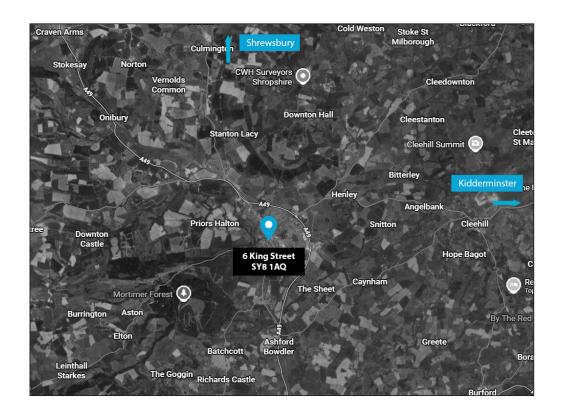
The property fronts directly onto Bridgnorth's High Street, the town's prime retail pitch, offering outstanding pedestrian and roadside exposure. Situated in the heart of the town centre, it benefits from excellent connectivity, with the A458 and A442 providing direct access to the surrounding road network

Key Location Highlights

- Excellent road links via the A458 (towards Shrewsbury and Stourbridge) and A442 (towards Telford and Kidderminster).
- Just a short walk from Bridgnorth's heritage Severn Valley Railway station, a major tourist draw.
- In the immediate vicinity are prominent national retailer occupiers including Tesco, Boots, Specsavers, and Grapetree, reinforcing the area's strong retail footprint.
- Bridgnorth boasts historic attractions such as the Cliff Railway, the 12thcentury Bridgnorth Castle ruins, Northgate Museum, and a lively weekly Charter Market.
- Rich local economy with nearly 250 commercial units in the town centre, strong retail employment, and a healthy visitor economy.

This property offers a high-traffic, commercially vibrant location, surrounded by well-known retailers and cultural landmarks. Its connectivity by road and public transport and its position in a proven visitor destination make it ideally placed for both retail and potential mixed-use development.

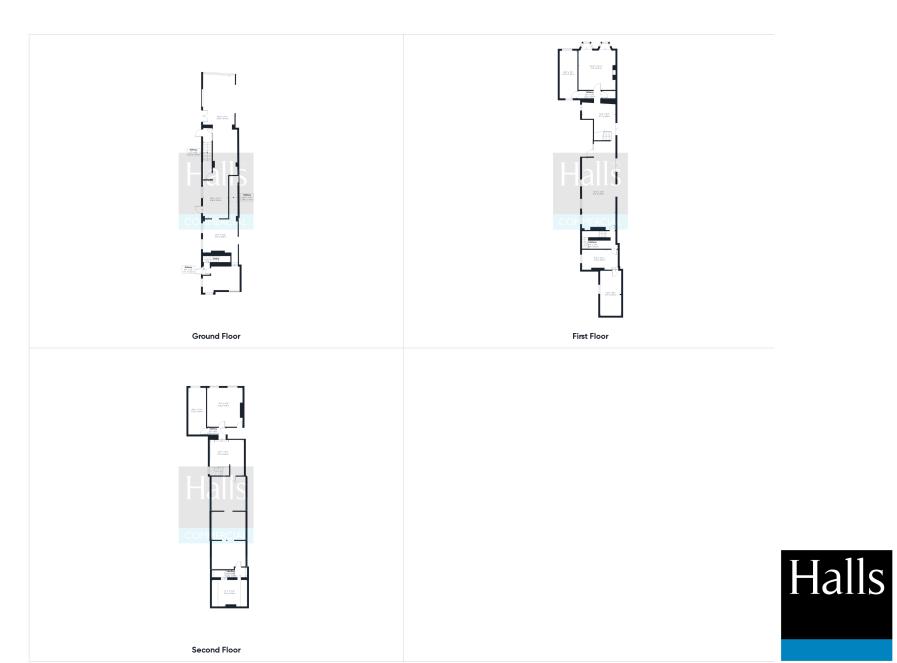
