Location

The property occupies an established retailing/leisure position amongst a range of national and independent traders including Joules, Café Nero, Go Outdoors, Natwest Bank and Blacks. Shrewsbury Market Hall and the main retail area of Pride Hill is within a short walking distance. There is on street parking within the local vicinity with short stay car parks on Hill's Lane.

Shrewsbury is the County Town and administrative centre of Shropshire, strategically located at the intersection of the main A49 and A5 trunk road approximately 55 miles north west of Birmingham, 18 miles west of Telford and 40 miles south of Chester

Description

The property comprises a substantial 4 storey café/bar premises extending to approximately 1,369 sqft (127.17 sqm) having an attractive glazed frontage. The accommodation is well-appointed providing ground floor servery and seating area, with further customer seating on the first floor.

The property benefits from a large amount of storage, with access to a cellar to the ground floor and a large attic space occupying the second floor. Formerly used as a creperie/café, the property has also previously had an alcohol license for serving craft beers, and is deemed suitable for a variety of uses, subject to planning.

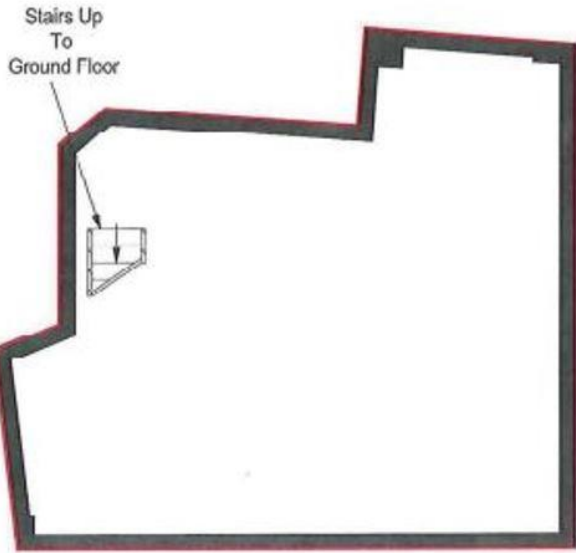

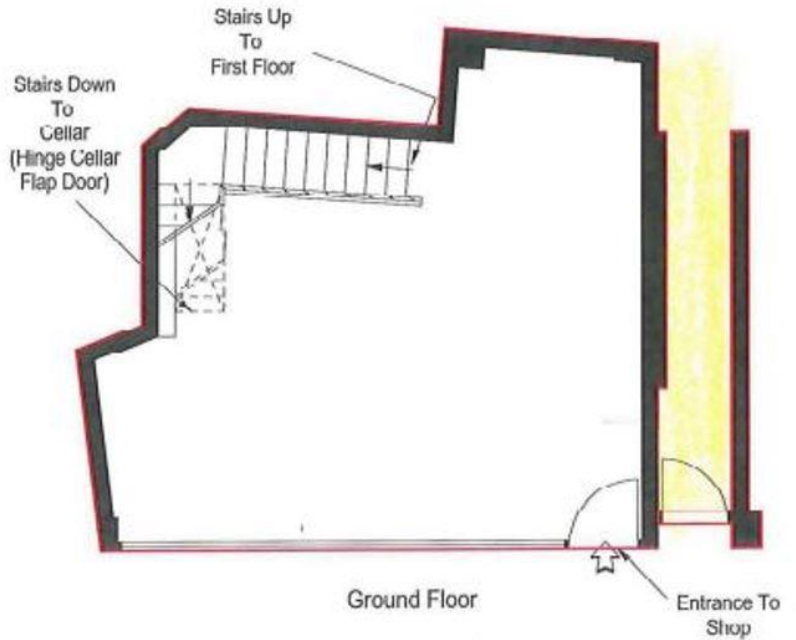

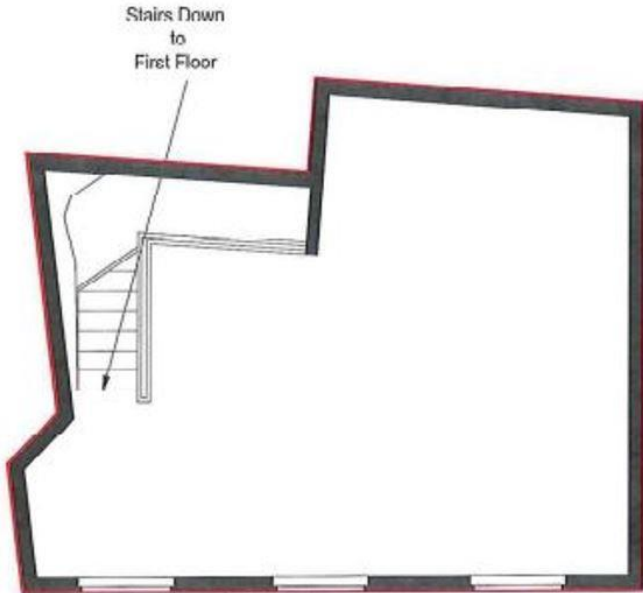


Cellar

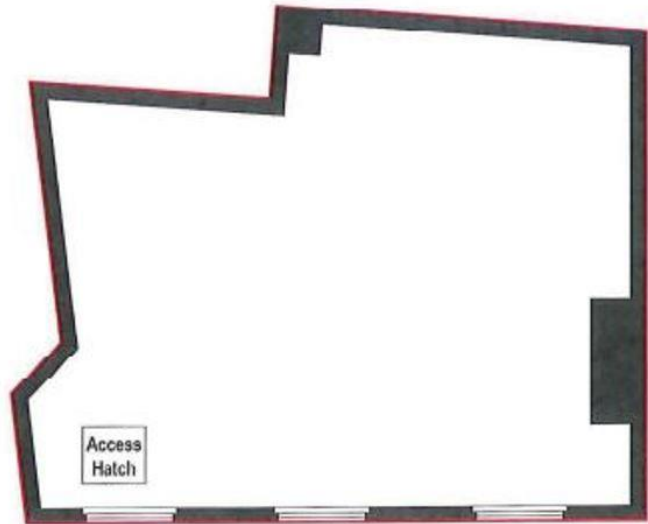


Ground Floor
