First Floor Office Suite

Description

Link House is a 1980s detached office building set within 0.65 acre site including car park surrounded by trees.

The building comprises two storeys split into north and south wings with communal central core/entrance. There is an entry system to the main doors.

The suite is located on the first floor and comprises a largely open plan main office area with private office and server / storeroom. In addition is an adjacent smaller office / meeting room. Next to the office is the communal kitchen and WCs. There is LED lighting throughout with carpeted flooring and perimeter trunking and an air conditioning and central heating system.

The suite benefits from 6 x allocated parking spaces. It is understood permits can be obtained for the Lysses car park nearby.


