The premises comprise two industrial units which have been fully rebuilt to provide high quality accommodation. The units have been stripped back to steel frame and re-clad with insulated steel profile sheeting including translucent panels to the roof area.

Externally to the front of the properties there is a secure yard and car parking area accessed via a steel palisade gate. Goods access to the units is via 3 up and over ground level roller shutters.
