Location

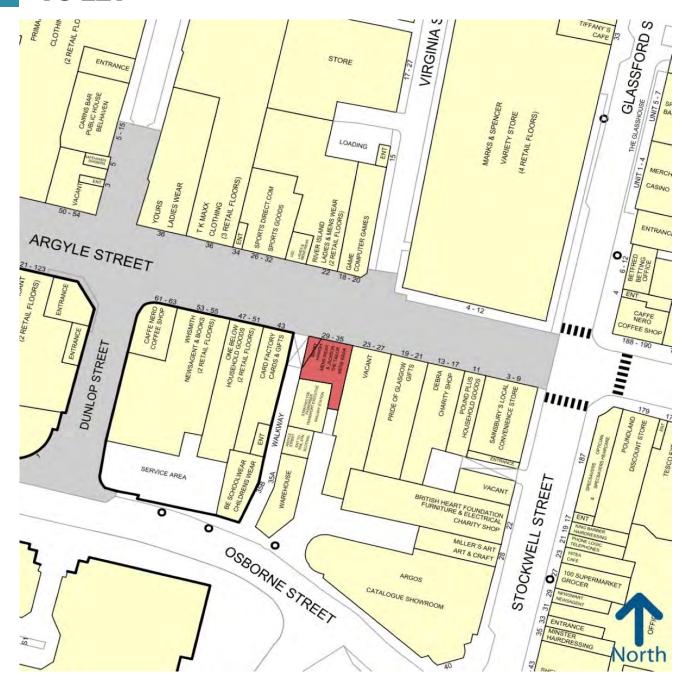
