The location offers an attractive mix of convenience retail, cafés, and independent businesses, creating a lively hub that serves both local residents and the wider community.

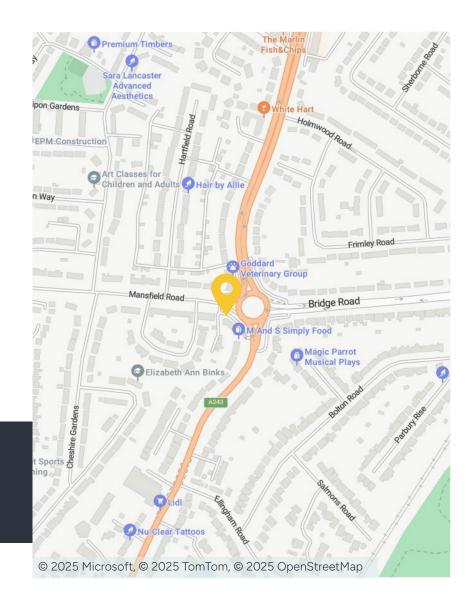
