Description

The available premises form the ground and first floor of a two storey office building, of brick and block construction under pitched roof. Access is taken from Tatton Street via a pedestrian door. A shared door allows the potential to split the ground and first floors if required.

Both floors feature open plan office space with WC and kitchen facilities. The first floor includes two glass partitioned meeting rooms. To the rear, an entrance vestibule provides access to the car park. The car park provides 5 convenient spaces which are available via separate negotiations.

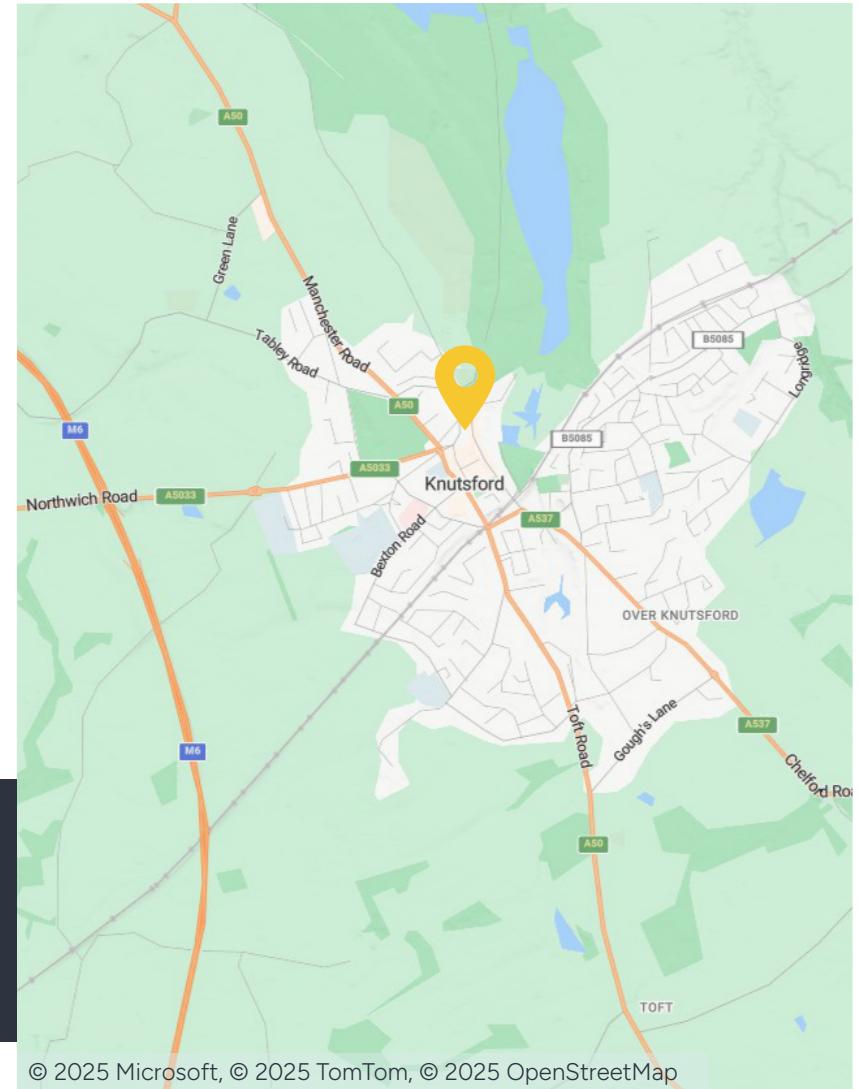

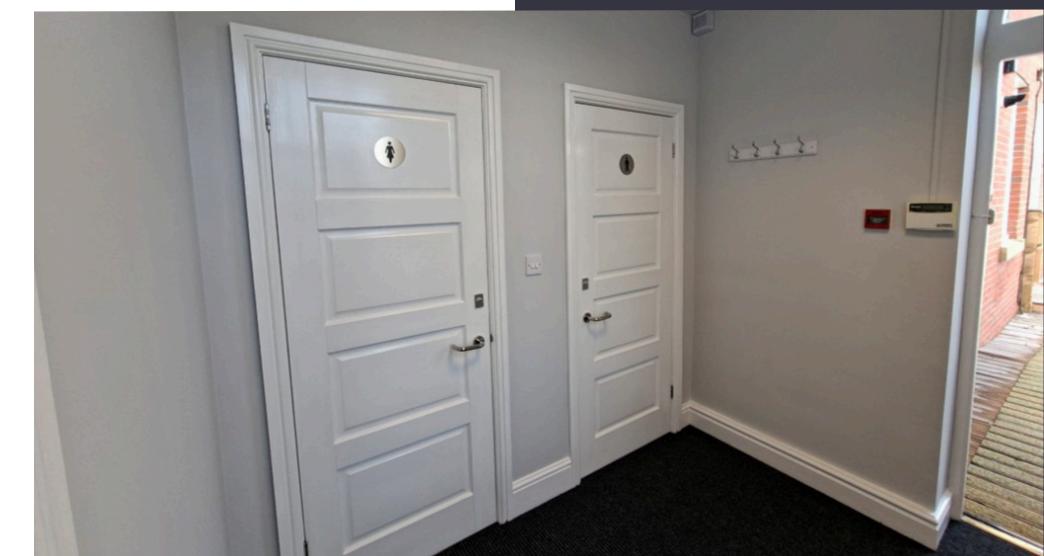
