- Successful s73 amendment, granted on 04/07/2024 for the addition of a 2nd stair core to comply with fire regulations.

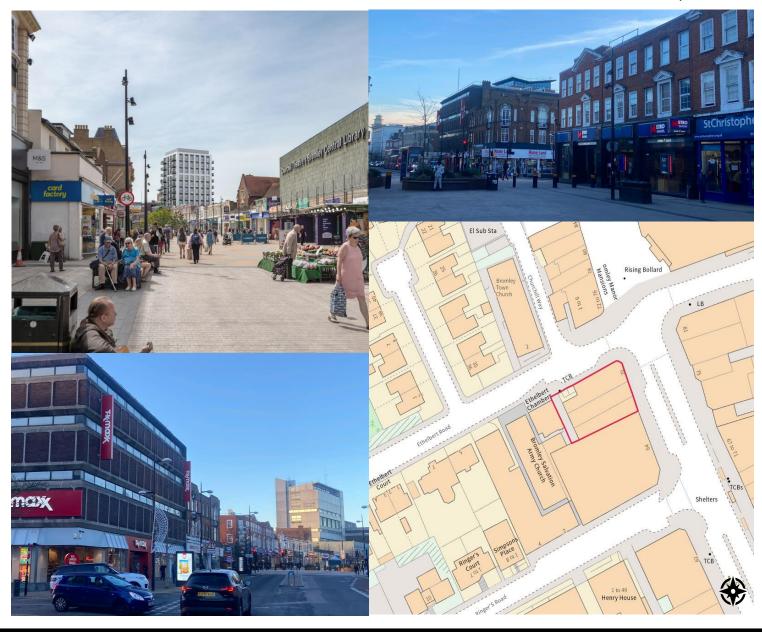
The Site is located on Bromley High Street, just a short walk from Bromley South Station.

Bromley is one of the greenest Boroughs in London with over half of the Borough comprising green space, parks, and gardens. Within Bromley's town centre itself are the tranquil Church House Gardens and both Shortlands Golf Club and Bromley Gold Club are a short distance from the town centre. In the surrounding area are the open green spaces of Jubilee Country Park in Petts Wood as well as Chislehurst's Scadbury Park.

Bromley provides a wide array of shops and restaurants within the town centre, including the Glades shopping centre which has varied mix of aspirational retailers including the Apple Store, Marks & Spencer and L'Occitane as well as restaurants such as Wagamama and Yo! Sushi.

In addition, there are numerous independent and chain restaurants in Bromley including noteworthy Italian Don Giovanni, Dorothy and Marshall, and popular pizza chain Franco Manca. In terms of grocery shopping, there is a Sainsburys, Tesco and Lidl all located on the high street. Bromley provides an ideal place for young families with more than 90% of the schools in Bromley rated as Good or Outstanding.

By Rail

At peak time there are up to 5 fast trains per hour to London Victoria LONDON VICTORIA (SOUTH EASTERN) with a typical journey time of just 18 minutes as well as a further 4 stopping services per hour. Bromley South is in Travel Card Zone 5.

Due to its prominent position on the high street, there are several regular bus services on the doorstep.

BY ROAD

The A21 (Bromley Road) is approximately 0.5 miles from the site, it is a major road running through Bromley, connected to the M25 motorway, providing access to London and other regions. The Site is located a 50-minute drive (25.2 miles) from Gatwick Airport via the M23.

PLANNING AND DEVELOPMENT

PLANNING

Planning permission (Ref: 19/04588/FULL1) was granted at appeal in November 2022 for a residential-led scheme of 47 apartments and ground floor retail space. The scheme comprises the demolition of the existing building and a replacement part-4 part-12 floor building.

A Section 73 Application, with updated drawings was granted on 04/07/2024 - application reference 19/04588/FULL1.

The drawings have been amended to account for a second escape stair, ensuring the scheme is compliant with current building regulations and free of restrictions, whilst maintaining 47 residential units.

The residential unit mix comprises 3no studios, 24no one beds, 20no two beds (17 x 2B3P, 2B4P). 38 of the 47 apartments are dual aspect and almost all have access to private terrace or balconies.

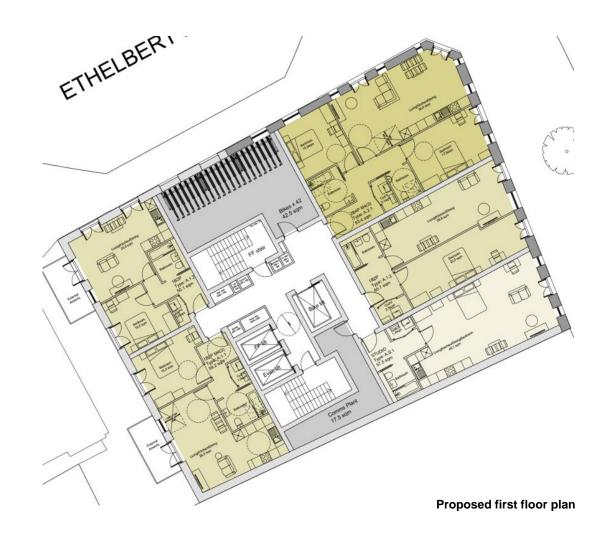
The agreed affordable housing provision is 10 units (21% by unit number), all of which are Shared Ownership tenure.

We understand that the Section 106 obligations total £95,100.04

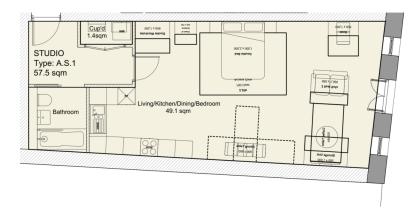
We await Bromley Borough Council's confirmation of the CIL Liability for the approved s73 scheme which is currently being finalised.

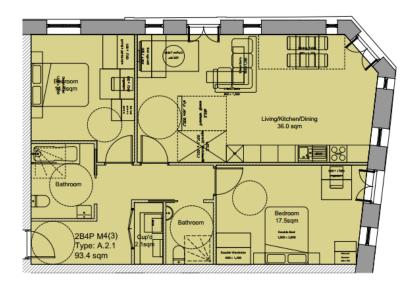
