The property comprises primarily open-plan warehouse space and is

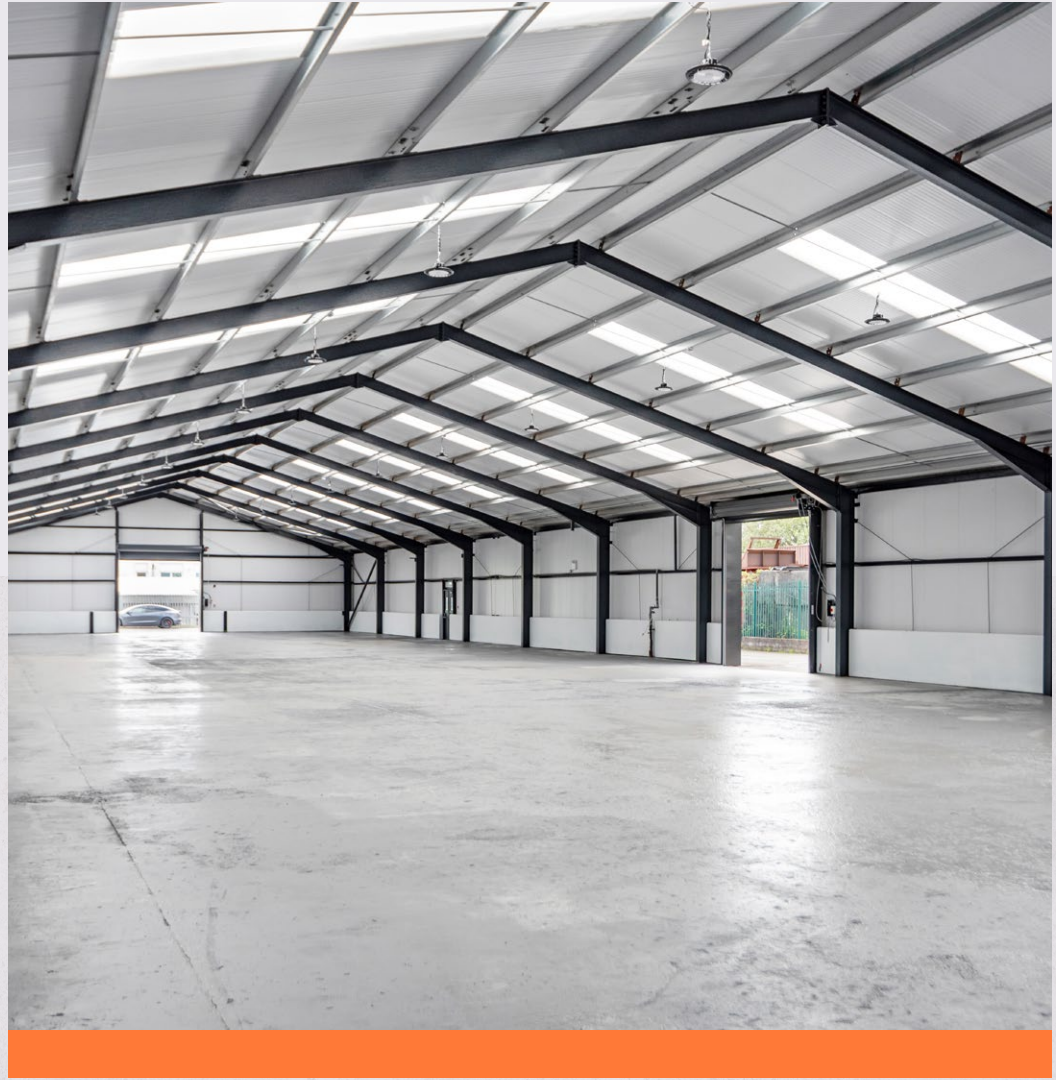

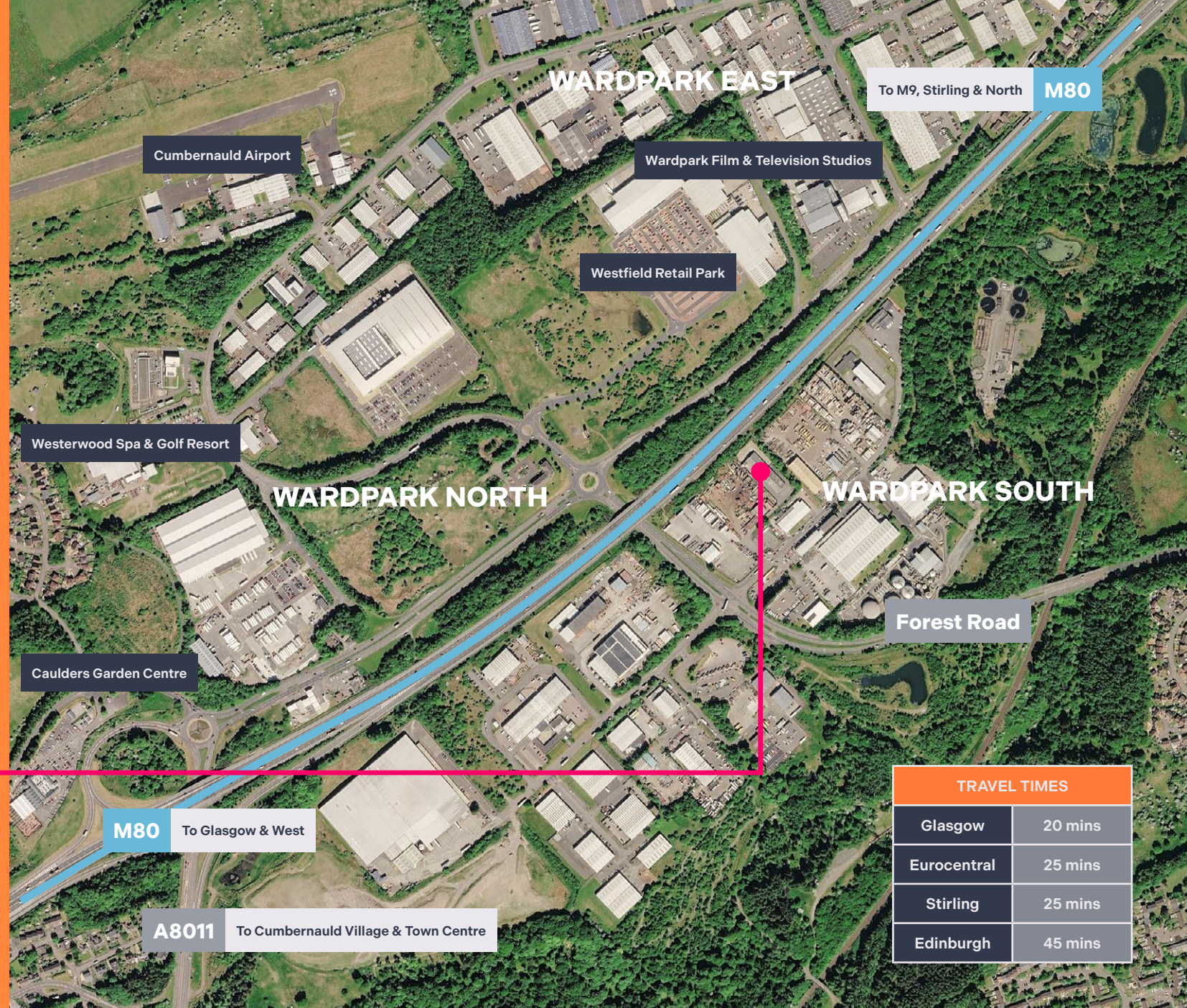
