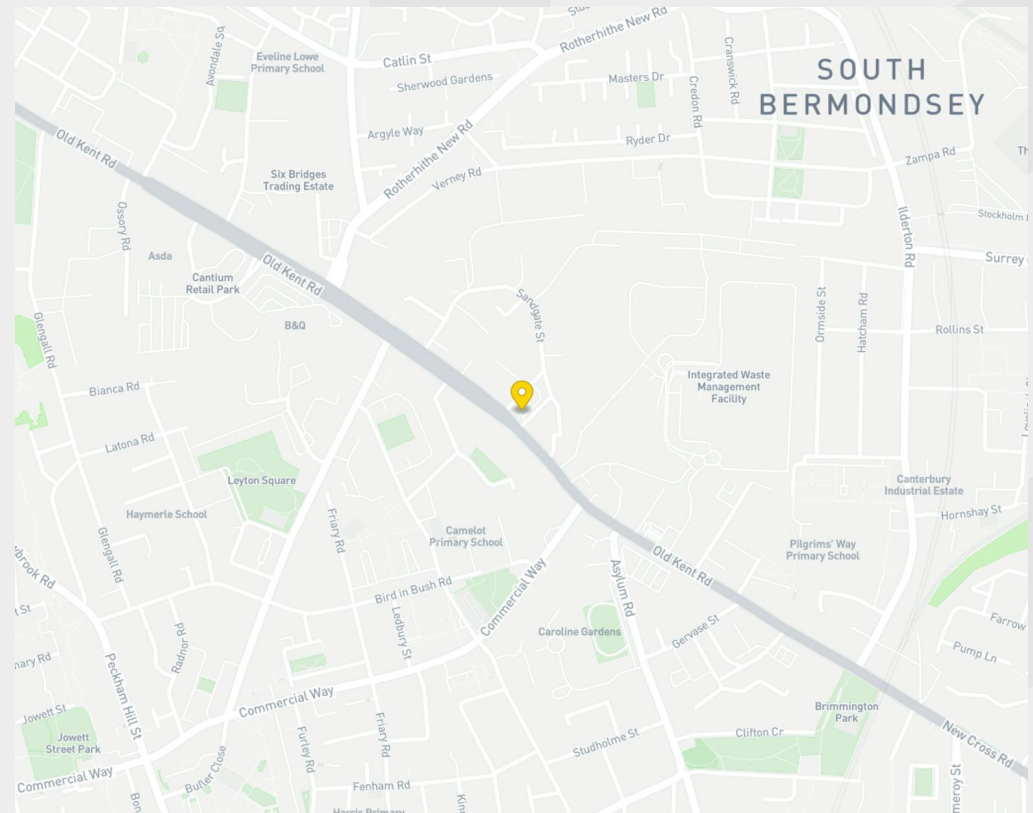


Description

Fronting the ground floor of a new 267 bedroom student hall, the unit is roughly rectangular in shape with a 69 foot frontage to Old Kent Road, and return frontages to Hyndman Street and Ruby Street. The self contained unit has good ceiling height and is fitted with lighting and WCs.

Prominently situated on Old Kent Road, the busiest road in south London, at the heart of a regeneration area where 20,000 new homes and 10,000 new jobs are planned. Developments include c. 1,100 flats in the Beca next door and c. 1,100 new homes and commercial space in Berkeley homes development in Malt Street, both of which are underway. 2 new tube stations are proposed nearby.
