The building features an impressive communal entrance and public-facing areas at ground floor level, centred around a striking atrium. The top floor office benefits from excellent levels of natural light and is set back from the original façade, enhancing views and creating a strong sense of openness.

## Location

The Town Hall is prominently located on the south side of Whitechapel Road, immediately adjacent to the Royal London Hospital. Whitechapel Station (Elizabeth, District, Hammersmith & City and Overground lines) is directly opposite, providing exceptional connectivity across Central London. The area benefits from a thriving street market alongside a wide range of cafés, restaurants and local retailers.
