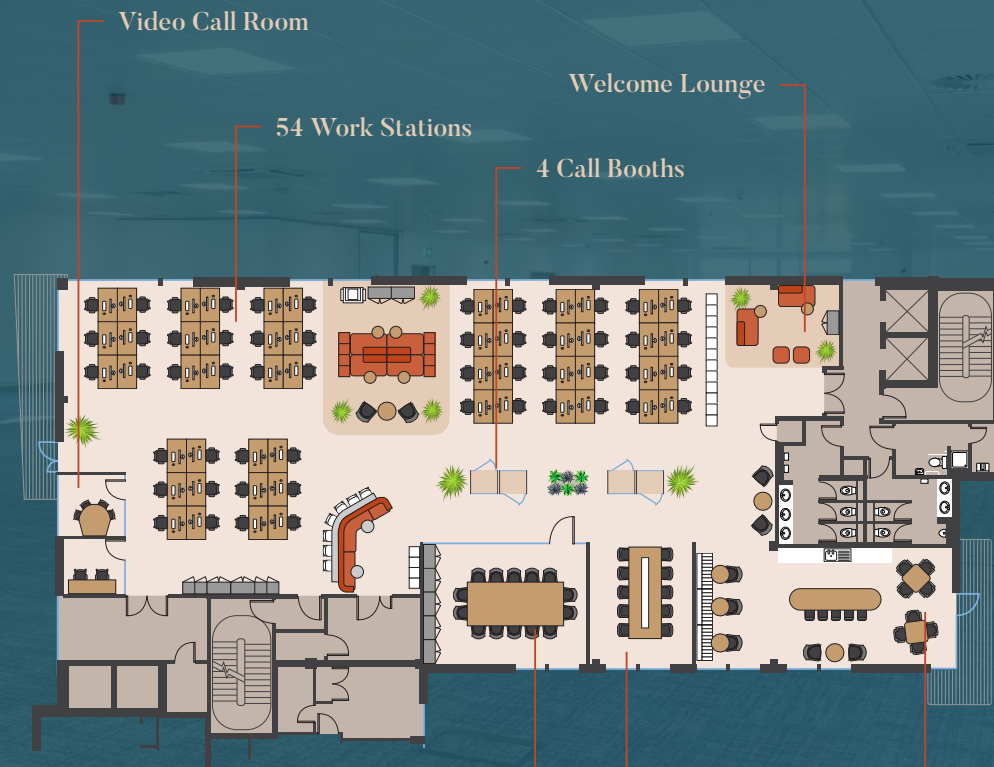

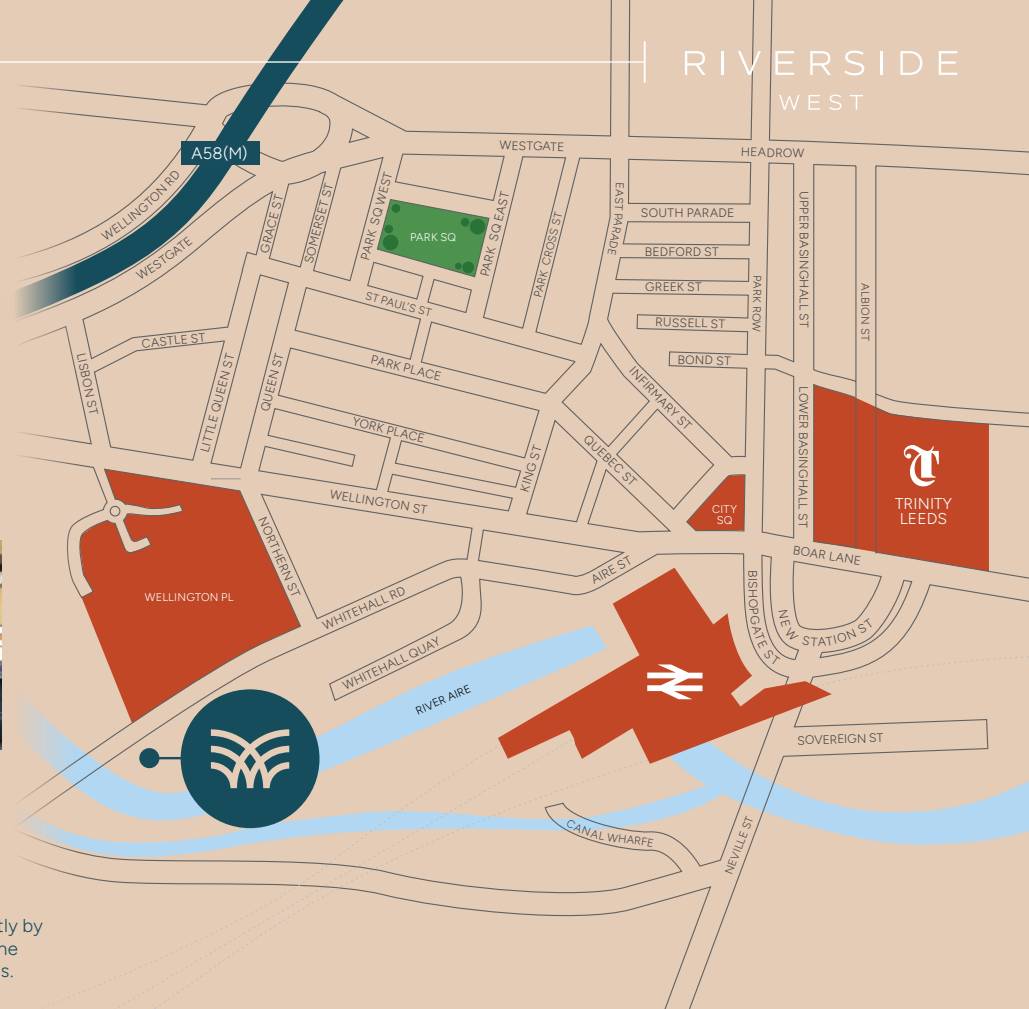
Typical
