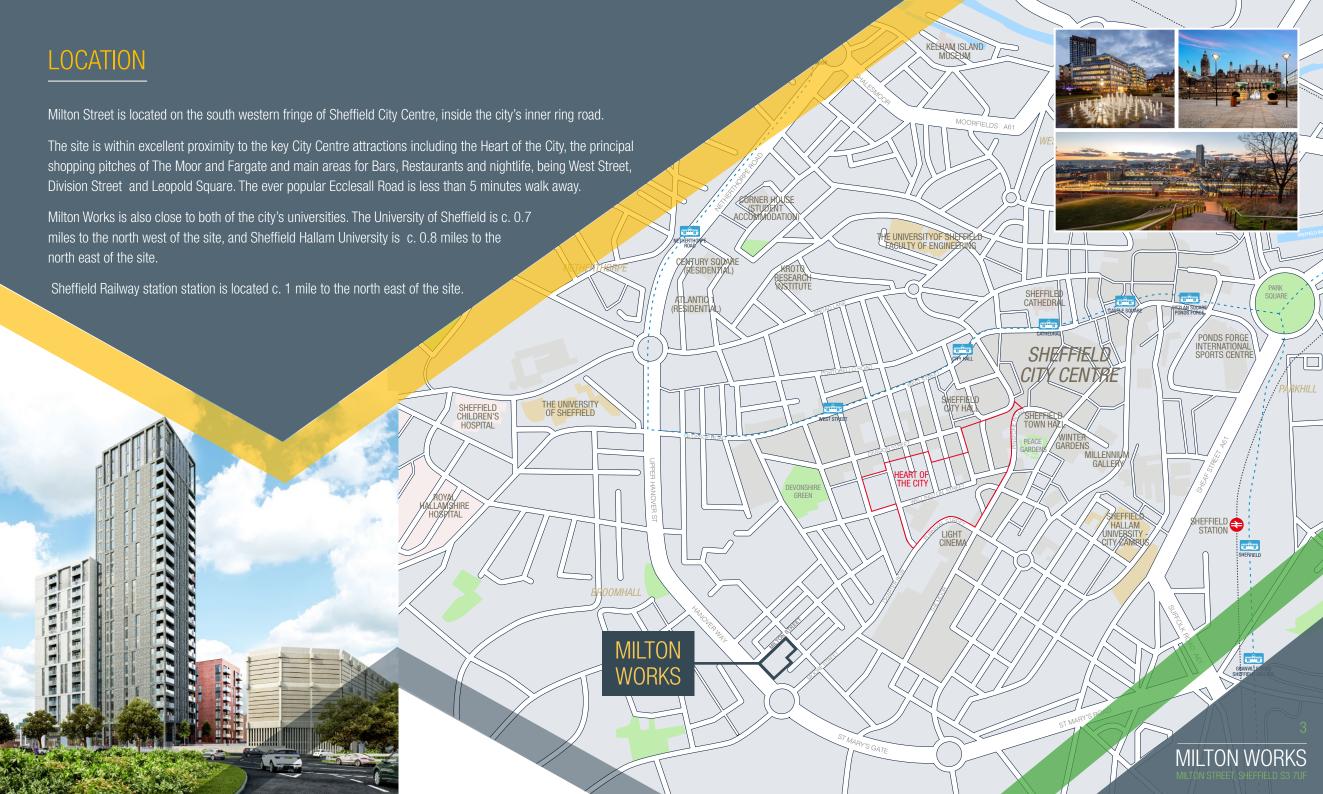




DESCRIPTION

- The property extends to 0.60 ha (1.49 acres) and is irregular in shape.
- The site is generally flat and level, and the majority of the site is currently used as a surface car park.
- There are the minor remnants of the former works in the south east of the site, in the form of brick and stone walls which will need to be demolished in order to facilitate the consented scheme.
- The site has frontage onto
 Milton Street, Headford Street,
 Hanover Way and Hodgson Street.
 Access to the site can be gained
 from either Hodgson Street
 or Milton Street.



TOWN PLANNING

The site was granted full planning consent for "Demolition of existing structures and erection of a mixed-use development between 4 to 26 storeys with 372 residential apartments including 5 live work units, retail/commercial floorspace (A1 with no more than 225sqm of floorspace/A2/A3/A4/B1 Use Class) at ground floor, ancillary facilities, amenity space and associated parking (As Amended Plans)" on 29th August 2019 (ref: 18/03849/FUL (Formerly PP-06866526)).

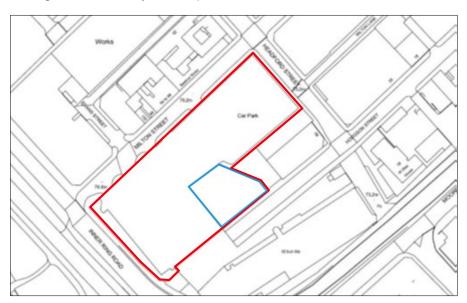
